## THE INTERMEDIATE SCHOOLS AND DEPARTMENTS (ADMISSION OF PUPILS) REGULATIONS 1967

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title—These regulations may be cited as the Intermediate Schools and Departments (Admission of Pupils) Regulations 1967.
- 2. Qualification for admission—Except where in special circumstances the Director-General approves otherwise, no pupil shall be qualified for admission to an intermediate school or intermediate department unless he has completed a course in Standard 4 at a registered school providing primary education.
- 3. Pupils to be admitted—An Education Board or the governing body of any school to which an intermediate department is attached shall admit to an intermediate school or intermediate department under its control only those pupils who, being qualified for admission in accordance with regulation 2 of these regulations, fall within the following categories, namely—

(a) Pupils who have completed a course in Standard 4 or Form I at a school determined by the Minister as a school which is to be a contributing school in relation to the intermediate school or department:

(b) Pupils normally residing in the school district of any school determined by the Minister as a school which is to be a contributing school in relation to the intermediate school or department:

(c) Pupils whom the Education Board or the governing body, as the case may be, may approve for admission on the recommendation of the District Senior Inspector:

(d) Pupils who, in the opinion of the District Senior Inspector, require special education of a kind which can be provided most appropriately in an intermediate school or department:

Provided that the Education Board or the governing body, as the case may be, shall not admit any pupil under paragraph (c) or paragraph (d) of this regulation until it has made full provision for the admission of pupils under paragraphs (a) and (b) of this regulation.

- 4. Admission from defined contributing areas in certain cases—In any case where a school has been determined by the Minister as a contributing school in relation to more than one intermediate school, the Minister may, for the purposes of regulation 3 of these regulations, define the areas of the school district of that school which will contribute to each intermediate school; and, in every such case, the school shall, for the purposes of the admission of pupils under paragraphs (a) and (b) of regulation 3 of these regulations, be deemed to be a contributing school in relation to each intermediate school only in respect of the contributing area so defined in relation to the intermediate school.
- **5. Revocations**—The regulations specified in the Schedule to these regulations are hereby revoked.
