

THE INCORPORATED SOCIETIES REGULATIONS 1938, AMENDMENT NO. 4

ORDER IN COUNCIL

At the Government House at Wellington this 2nd day of August 1976

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL BY HIS DEPUTY IN COUNCIL

Pursuant to the Incorporated Societies Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Incorporated Societies Regulations 1938, Amendment No. 4, and shall be read together with and deemed part of the Incorporated Societies Regulations 1938* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 14th day after the date of their notification in the Gazette.
- 2. Formal requirements relating to documents—Regulation 12 of the principal regulations (as added by regulation 2 of the Incorporated Societies Regulations 1938, Amendment No. 1) is hereby amended by revoking subclause (1), and substituting the following subclause:
- "(1) All documents prepared to be registered or to be delivered, sent, or forwarded to the Registrar shall be legibly and clearly written, typewritten, or printed on A4 international size paper of medium weight and good quality, with a binding margin of at least one-fourth of the width of the paper. Where there are more sheets than one they shall be fastened together with a sufficient fastener at the top left-hand corner."

are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 requires documents presented for registration or filing under the Incorporated Societies Act 1908 to be of A4 international size, instead of foolscap. Regulation 3 prescribes a new and increased scale of fees payable to the Registrar of Incorporated Societies.
