PURSUANT to section EL 8 of the Income Tax Act 1994, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title—This order may be cited as the Income Tax (Average Market Values of Specified Livestock) Order 1996.

2. Application—This order shall apply with respect to specified livestock on hand at the end of the 1995-96 income year.

3. Average market values of specified livestock—For the purposes of section EL 8 of the Income Tax Act 1994, it is hereby declared that the average market values of specified livestock are those set out in the Schedule to this order.
