### **ORDER**

- 1. Title—This order may be cited as the Income Tax (National Standard Costs for Specified Livestock, 1995–96) Order 1996.
- 2. National standard costs for specified livestock—For the purposes of section EL 4 of the Income Tax Act 1994, it is hereby declared that, in relation to the 1995–96 income year, the national standard costs for each category of specified livestock listed in column 2 of Schedule 9 to the Income Tax Act 1994 are those set out in the Schedule to this order.
