ORDER IN COUNCIL

At the Government House at Wellington this 27th day of November 1978

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT—

- (a) In relation to the Judges of the Court of Appeal and the Judges of the Supreme Court, to section 3 (1) (b) of the Judicature Amendment Act 1978, and on the recommendation of the Minister of Justice made after consultation by him with the Chief Justice:
- (b) In relation to the Judges of the Arbitration Court (not being temporary Judges), to section 39 (1) (b) of the Industrial Relations Act 1973:
- (c) In relation to the Judge of the Industrial Court (not being a temporary Judge), to section 39 (1) (a) of the Industrial Relations Act 1973 and section 3 (2) of the Industrial Relations Amendment Act 1978:
- (d) In relation to the Judge of the Compensation Court, to section 42 (1) (b) of the Workers' Compensation Act 1956:
- (e) In relation to the Judges of the Maori Land Court, to section 21 (1) (b) of the Maori Affairs Act 1953:
- (f) In relation to Magistrates, to section 6 (1) (b) of the Magistrates' Courts Act 1947,—

His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Judicial Allowances Order 1978.

(2) Except as provided in clause 3 (2) of this order, this order shall be deemed to have come into force on the 1st day of April 1978.

2. Allowances for general expenses of Judges and Magistrates— Allowances for general expenses shall be paid to the Judges of the Court of Appeal, the Judges of the Supreme Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and Magistrates at the respective rates set out in the Schedule to this order.

3. Salary of Judge of the Industrial Court—(1) The salary payable to the Judge of the Industrial Court (not being a temporary Judge) shall—

(a) In respect of the period commencing on the 11th day of October 1977 and ending with the close of the 31st day of March 1978, be paid at the rate of \$34,444 a year; and

(b) In respect of the period commencing on the 1st day of April 1978 and ending with the close of the 16th day of April 1978, be paid at the rate of \$42,500 a year.

(2) This clause shall be deemed to have come into force on the 11th day of October 1977.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order prescribes the allowances for general expenses which are payable to judicial officers. These allowances were recommended by the Higher Salaries Commission. Except in the case of the Judges of the Arbitration Court, the allowances take effect on and after 1 April 1978. In the case of the Judges of the Arbitration Court, the allowances take effect on 17 April 1978, the date on which that Court was reconstituted.

This order also prescribes the salary payable to the Judge of the Industrial Court in respect of the period commencing with 11 October 1977 and ending with 16 April 1978. The Industrial Court was replaced by the Arbitration Court on 17 April 1978.
