ORDER IN COUNCIL

At the Government Buildings at Wellington this 19th day of April 1982

THE RIGHT HON. D. S. THOMSON PRESIDING IN COUNCIL

PURSUANT to section 20 (1) of the Joint Council for Local Authorities Services Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Joint Council for Local Authorities Services (Levy) Order 1982.
- (2) This order shall come into force on the 14th day after the date of its notification in the Gazette.
- 2. Basis of levy on local authorities—Any levy that the Joint Council imposes under section 20 (1) of the Joint Council for Local Authorities Services Act 1977 on the local authorities specified in the Second Schedule to that Act shall be imposed on the basis that—
 - (a) The levy shall be an annual levy relating, in the case of each such local authority, to the number of persons employed by it—
 - (i) In the case of the year 1982; and
 - (ii) In the case of each subsequent year,—

on the 1st day of January; and

- (b) The scale set out in the Schedule to this order shall apply in respect of the levy; and
- (c) The amount of the levy imposed on any such local authority shall not exceed the amount applicable in respect of that local authority under the Schedule to this order.
- **3. Revocation**—The Joint Council for Local Authorities Services (Levy) Order 1981* is hereby revoked.

EXPLANATORY NOTE

The order makes provision for an increased levy. The levy is for the purpose of meeting the net expenditure of the Council.
