ORDER IN COUNCIL

At Wellington this 25th day of July 1988

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 20 (1) of the Joint Council for Local Authorities Services Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

---

ORDER

**1. Title and commencement**—(1) This order may be cited as the Joint Council for Local Authorities Services (Levy) Order 1988.

(2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.

**2. Basis of levy on local authorities**—Any levy that the Joint Council imposes under section 20 (1) of the Joint Council for Local Authorities Services Act 1977 on the local authorities specified in the Second Schedule to that Act shall be imposed on the basis that—

(a) The levy shall be an annual levy relating, in the case of each such local authority, to the number of persons employed by it—

(i) In the case of the year 1988; and

(ii) In the case of each subsequent year,—

on the 1st day of January; and

- (b) The scale set out in the Schedule to this order shall apply in respect of the levy; and
- (c) The amount of the levy imposed on any such local authority shall not exceed the amount applicable in respect of that local authority under the Schedule to this order.

**3. Amount of goods and services tax included**—It is hereby declared that the maximum rates of levy set out in the Schedule to this order are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

**4. Revocation**—The Joint Council for Local Authorities Services (Levy) Order 1987\* is hereby revoked.

## EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order alters the basis on which the Joint Council for Local Authorities Services may impose a levy on the local authorities specified in the Second Schedule to the Joint Council for Local Authorities Services Act 1977. The order makes provision for an increased levy. The levy is for the purpose of meeting the net expenditure of the Council.

The maximum rates of levy set out in the Schedule to the order are inclusive of goods and services tax.
