THE JURIES REGULATIONS 1964, AMENDMENT NO. 1

ORDER IN COUNCIL

At the Government Buildings at Wellington this 13th day of March 1967

Present:

THE RIGHT HON. J. R. MARSHALL PRESIDING IN COUNCIL

PURSUANT to the Juries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Juries Regulations 1964, Amendment No. 1, and shall be read together with and deemed part of the Juries Regulations 1964* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Form 2 in the Schedule to the principal regulations is hereby amended—

(a) By inserting, after the words “more than 15 miles”, the words “by the most practicable route”:

(b) By adding to the list of exemptions set out in clause 1 on the back of that form the following new paragraphs:

“(t) A member of a Board of Review established under the Inland Revenue Department Amendment Act 1960:

“(u) An employee of the Public Service who is employed in the Police Department:

“(v) The Director of Civil Defence, the Deputy Director of Civil Defence, a Regional Commissioner of Civil Defence, the Deputy of a Regional Commissioner of Civil Defence, or an Assistant Regional Commissioner of Civil Defence.”

3. The Schedule to the principal regulations is hereby further amended by revoking Form 4, and substituting the new Form 4 set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Juries Regulations 1964 by making amendments that are consequential on the enactment of the Jury Service Exemption Order 1965, the Jury Service Exemption Order 1966, and the Juries Amendment Act 1966.
