HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 35 of the Juries Act 1981, His Excellency the Governor General, acting on the advice of the Minister of Justice tendered after consultation with the Chief Justice, the Chief District Court Judge, and the President of the New Zealand Law Society, and by and with the advice and consent of the Executive Council, hereby makes the following rules.

RULES

- 1. Title and commencement—(1) These rules may be cited as the Jury Rules 1982, Amendment No. 6, and shall be read together with and deemed part of the Jury Rules 1982* (hereinafter referred to as the principal rules).
 - (2) These rules shall come into force on the 1st day of August 1988.
- 2. New scale of fees and expenses substituted—(1) The principal rules are hereby amended by revoking the Second Schedule (as substituted

by rule 3 of the Jury Rules 1982, Amendment No. 5), and substituting the Second Schedule set out in the Schedule to these rules.

- (2) The Jury Rules 1982, Amendment No. 5 are hereby amended by revoking rule 3.
- **3. Goods and services tax not included**—The fees and expenses prescribed by these rules are exclusive of any goods and services tax that is payable under the Goods and Services Tax Act 1985.

Rule 26 "SECOND SCHEDULE
FEES AND EXPENSES

PART A

Fees

1. The rates at which fees shall be paid to jurors for attendance at sittings of the Court, whether in civil or criminal cases, shall be as follows:

(a) For every day on which attendance is required for a period	
not exceeding 3 hours	17.00
Provided that the fees prescribed by paragraph (b) of	
this clause may be paid in any case where the Registrar is	
satisfied that the juror, through attendance at Court, will	
be absent from work for a full day:	
(b) For every day on which attendance is required for a period	
exceeding 3 hours	34.00
Provided that where attendance is required after 6	
o'clock in the afternoon but not later than 9 o'clock in	
the evening, the fee shall be	48.00
And provided further that where attendance is	
required after 9 o'clock in the evening, the fee shall be	69.00

2. Notwithstanding clause 1 of this Part, the Secretary may authorise the sums payable under that clause to be increased in any case where the Secretary considers that, by reason of exceptional circumstances, it is desirable to do so.

SCHEDULE—continued

PART B

Expenses

The expenses to be paid to jurors for travelling to and returning from any sittings of the Court shall be as follows:

(a) The actual cost of travelling by public conveyance:

(b) In special circumstances, where the Registrar thinks fit, the cost of travelling by taxi:

(c) Where no public conveyance is available, and no allowance is made under paragraph (b) of this Part, if the distance travelled exceeds 3 kilometres one way, an allowance at the rate of 38c a kilometre."

EXPLANATORY NOTE

This note is not part of the rules, but is intended to indicate their general effect.

These rules, which come into force on 1 August 1988, increase the fees and expenses payable to jurors. The new fees and expenses are exclusive of any goods and services tax that is payable under the Goods and Services Tax Act 1985.
