THE JUDICIAL SALARIES AND ALLOWANCES DETERMINATION (NO. 2) 1991

PURSUANT to section 21 (1) (a) and (b) of the Maori Affairs Act 1953 (as substituted by section 2 of the Maori Affairs Amendment Act (No. 2) 1985) and section 9 (2) of the Maori Affairs Amendment Act 1991 and section 12B (1) (d) of the Higher Salaries Commission Act 1977, the Higher Salaries Commission hereby makes the following determination.

DETERMINATION

1. Title and commencement—(1) This determination may be cited as the Judicial Salaries and Allowances Determination (No. 2) 1991.

(2) This determination shall be deemed to have come into force on the 1st day of June 1987.

2. Salary and allowances of His Honour Judge Ashley George McHugh—Notwithstanding anything in the Judicial Salaries and Allowances Determination 1991* or in any other determination made before that determination, the salary and the principal allowance for general expenses payable to His Honour Judge Ashley George McHugh shall, in respect of the following periods, be paid at the following rates:

3. Extra duties—This determination takes account of the extra duties occasioned by His Honour Judge Ashley George McHugh acting in the period beginning on the 1st day of June 1987 and ending with the 20th day of June 1991 as the deputy of the Chief Judge of the Maori Land Court.

EXPLANATORY NOTE

This note is not part of the determination, but is intended to indicate its general effect.

This determination, which is deemed to have come into force on 1 June 1987, increases the salary and the principal allowance for general expenses payable to His Honour Judge Ashley George McHugh in respect of the period beginning on 1 June 1987 and ending with 20 June 1991. The determination takes account of the extra duties occasioned by His Honour acting in that period as the deputy of the Chief Judge of the Maori Land Court.
