 (a) and (b) of the Maori Affairs Act 1953 (as substituted by section 2 (1) of the Maori Purposes Act 1978):
- (e) In relation to the District Court Judges, to section 6 (1) (a) and (b) of the District Courts Act 1947 (as substituted by section 2 (1) of the District Courts Amendment Act 1978 and as amended by section 7A of the District Courts Amendment Act 1979 and by section 17 (1) of the Family Courts Act 1980),—

His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement-(1) This order may be cited as the Judicial Salaries and Allowances Order 1981.

(2) Except as provided in clauses 3 (3), 4 (3), and 5 of this order, this order shall be deemed to have come into force on the 10th day of November 1980.

2. Salaries of Judges-The salaries payable to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges shall be paid at the respective rates set out in the First Schedule to this order.

3. Allowances of Judges—(1) Allowances for general expenses shall be paid to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges at the respective rates set out in the Second Schedule to this order.

(2) Any District Court Judge who is appointed as the Chairman of any Division of the Planning Tribunal or as the Chairman of the Licensing Control Commission shall be paid, while he continues to hold office as such a Chairman, an allowance at the rate of \$2,000 a year as an addition to his salary, which allowance shall not be by way of reimbursement and shall not affect the payment of allowances under subclause (1) of this clause.

(3) This clause shall be deemed to have come into force on the 1st day of April 1981.

4. Salary and allowance of Principal Family Court Judge-(1) The salary payable to the District Court Judge who holds office as the Principal Family Court Judge shall be paid at the rate of \$55,793 a year.

(2) The allowance for general expenses payable to the District Court Judge who holds office as the Principal Family Court Judge shall be paid at the rate of \$1,000 a year.

(3) This clause shall be deemed to have come into force on the 1st day of October 1981.

5. Revocations and saving—(1) The Judicial Salaries Order (No. 2) 1981* is hereby revoked as from the commencement of the 11th day of June 1981.

(2) The Judicial Allowances Order 1978[†] is hereby revoked as from the commencement of the 1st day of April 1981.

(3) Nothing in this clause shall affect the revocation effected by clause 3 of the Judicial Salaries Order (No. 2) 1981.

ALLOWANCES FOR GENERAL EXPENSES

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order increases judicial salaries and judicial allowances in accordance with the recommendations of the Higher Salaries Commission.

The increases that take effect on 10 November 1980 give to judicial officers the full benefit of the 15.7 percent general adjustment that has been applied in the State services as at that date. Judicial officers had been given, as an interim measure, an increase of 12.5 percent as at that date.

The review conducted as at 1 April 1981 has resulted in increases in the salaries of Judges of the Maori Land Court.

The increases that take effect as at 11 June 1981 incorporate into judicial salaries the amount of the cost-of-living increase of 5 percent effected under the Economic Stabilisation (Cost-of-Living Increase) Regulations 1980.

Increased allowances for general expenses take effect on 1 April 1981. They replace the allowances that came into force on 1 April 1978.

An allowance of \$2,000 a year, as an addition to salary, is to be paid to any District Court Judge who also holds office as the Chairman of any Division of the Planning Tribunal or as the Chairman of the Licensing Control Commission.

The provisions relating to the salary and allowance of the Principal Family Court Judge are deemed to have come into force on the 1st day of October 1981 (the date of commencement of the Family Courts Act 1980).
