(a) and (b) of the Workers' Compensation Act 1956 (as substituted by section 2 (1) of the Workers' Compensation Amendment Act 1978):

(d) In relation to the Judges of the Maori Land Court, to section 21 (1)
(a) and (b) of the Maori Affairs Act 1953 (as substituted by section

2 (1) of the Maori Purposes Act 1978):

(e) In relation to the District Court Judges, to section 6 (1) (a) and (b) of the District Courts Act 1947 (as substituted by section 2 (1) of the District Courts Amendment Act 1978 and as amended by section 7A of the District Courts Amendment Act 1979 and by section 17 (1) of the Family Courts Act 1980),—

His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Judicial Salaries and Allowances Order 1984.
 - (2) This order shall come into force on the 1st day of April 1984.
- 2. Salaries of Judges—The salaries payable to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges shall be paid at the respective rates set out in the First Schedule to this order.
- **3.** Allowances of Judges—(1) Allowances for general expenses shall be paid to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges at the respective rates set out in the Second Schedule to this order.
- (2) Any District Court Judge who is appointed as the Chairman of any Division of the Planning Tribunal or as the Chairman of the Licensing Control Commission shall be paid, while he continues to hold office as such a Chairman, an allowance at the rate of \$2,000 a year as an addition to his salary, which allowance shall not be by way of reimbursement and shall not affect the payment of allowances under subclause (1) of this clause.
- **4. Revocation**—The Judicial Salaries and Allowances Order 1982* is hereby revoked.

This order, which comes into force on 1 April 1984, increases judicial salaries by the amount of the cost-of-living increase effected by the Economic Stabilisation (Cost-of-Living Allowance) Regulations 1984. This order does not effect any change in the rates of judicial allowances.
