

THE JUDICIAL SALARIES INTERIM DETERMINATION 1988

PURSUANT to section 8 (2) of the Higher Salaries Commission Amendment Act 1988 and,—

- (a) In relation to the Chief Justice, the President of the Court of Appeal, the Judges of the Court of Appeal and the other Judges of the High Court, to both section 9A (1) (a) and (b) of the Judicature Act 1908 (as inserted by section 2 of the Judicature Amendment Act (No. 3) 1985) and the Higher Salaries Commission Act 1977:
- (b) In relation to the Chief Judge of the Labour Court and the other Judges of the Labour Court, to both section 290 of the Labour Relations Act 1987 and the Higher Salaries Commission Act 1977:
- (c) In relation to the Chief Judge of the Maori Land Court and the other Judges of the Maori Land Court, to both section 21 (1) (a) and (b) of the Maori Affairs Act 1953 (as substituted by section 2 of the Maori Affairs Amendment Act (No. 2) 1985) and the Higher Salaries Commission Act 1977:
- (d) In relation to the Chief District Court Judge, the Principal Family Court Judge, the Principal Planning Judge, and the other District Court Judges, to both section 6 (1) (a) and (b) of the District Courts Act 1947 (as substituted by section 2 of the District Courts Amendment Act (No. 3) 1985) and the Higher Salaries Commission Act 1977:
- (e) In relation to Masters of the High Court, to both section 26F (1) (a) and (b) of the Judicature Act 1908 (as inserted by section 5 of the Judicature Amendment Act 1986) and the Higher Salaries Commission Act 1977,—

the Higher Salaries Commission hereby makes the following determination (to which is appended an Explanatory Memorandum).

DETERMINATION

1. Title and commencement—(1) This determination may be cited as the Judicial Salaries Interim Determination 1988.

(2) This determination shall be deemed to have come into force on the 1st day of April 1988.

2. Salaries of Judges—The salaries payable to the Judges specified in the Schedule to this determination shall be paid at the respective rates set out in that Schedule.

3. Consequential revocations and amendment—(1) The Judicial Salaries and Allowances Determination (No. 2) 1987* is hereby consequentially amended by revoking clause 2 and so much of the First Schedule as relates to the yearly rate of salary payable on and after 1 December 1986.

(2) The Judicial Salaries and Allowances Determination (No. 3) 1987† is hereby consequentially amended—

- (a) By omitting from clause 2 the words “salaries payable to the Judges of the Labour Court and the allowances for general expenses payable to those Judges”, and substituting the words “allowances for general expenses payable to the Judges of the Labour Court”; and
- (b) By revoking so much of clause 2 as relates to the yearly rate of salary payable on and after 1 August 1987.

EXPLANATORY MEMORANDUM

This memorandum is not part of the determination, but is intended to indicate its general effect.

1. This interim determination, which is deemed to have come into force on 1 April 1988, revises the salaries payable to members of the Judiciary. It has been issued pursuant to section 8 (2) of the Higher Salaries Commission Amendment Act 1988, which provides that the Higher Salaries Commission may issue an interim determination with effect from 1 April 1988 to adjust the remuneration of any of the categories of persons who are covered by the principal Act. As required by the same section 8 (2) of the Amendment Act, the adjustments made are to be subsequently incorporated into a final determination which may have a term commencing on or after 1 April 1988.

2. The rates of allowances payable for general expenses prescribed by the Judicial Salaries and Allowances Determination (No. 2) 1987, and by the Judicial Salaries and Allowances Determination (No. 3) 1987 remain unchanged.
