### ORDER IN COUNCIL

His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

### ORDER

**1. Title and commencement**—(1) This order may be cited as the Judicial Salaries Order 1981.

(2) This order shall be deemed to have come into force on the 10th day of November 1980.

**2. Salaries of Judges**—The salaries payable to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges shall be paid at the respective rates set out in the Schedule to this order.

**3. Revocation**—The Judicial Salaries Order (No. 2) 1980\* is hereby revoked.

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which is deemed to have come into force on 10 November 1980, increases judicial salaries by 12.5 percent, being the amount of the interim adjustment applied to salaries above \$30,196 per annum in the State services.
