 - (e) In relation to Magistrates, to the Magistrates' Courts Act 1947,—
- His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Judicial Salaries Order (No. 2) 1978.

(2) Except as provided in clause 3 (4) of this order, this order shall be deemed to have come into force on the 11th day of October 1977.

2. Salaries of Judges and Magistrates—The salaries payable to the Judges of the Court of Appeal, the Judges of the Supreme Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and Magistrates shall be paid at the respective rates set out in the Schedule to this order.

3. Salaries of Judges of the Arbitration Court—(1) The salary payable to the Chief Judge of the Arbitration Court shall—

- (a) In respect of the period commencing on the 17th day of April 1978 and ending with the close of the 16th day of July 1978, be paid at the rate of \$42,500 a year; and
- (b) On and after the 17th day of July 1978, be paid at the rate of \$42,865 a year.
- (2) The salary payable to each Judge of the Arbitration Court (other than the Chief Judge or a temporary Judge) shall—
- (a) In respect of the period commencing on the 17th day of April 1978 and ending with the close of the 16th day of July 1978, be paid at the rate of \$35,000 a year; and
- (b) On and after the 17th day of July 1978, be paid at the rate of \$35,365 a year.
- (3) The Industrial Relations (Judges Salaries) Order 1978* is hereby revoked.
- (4) This clause shall be deemed to have come into force on the 17th day of April 1978.

4. **Revocation**—The Judicial Salaries Order 1978† is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which is deemed to have come into force on 11 October 1977, increases judicial salaries.

This order makes three separate adjustments.

The first adjustment of 12.6 percent relates to the period commencing with 11 October 1977 and ending with 31 March 1978. This adjustment of 12.6 percent (which incorporates the increase effected by the Judicial Salaries Order 1978) matches an increase applied to State Service salaries.

The second adjustment, which takes effect on 1 April 1978, reflects the result of the general review of judicial salaries carried out by the Higher Salaries Commission as at that date.

The third adjustment, which takes effect on 17 July 1978, incorporates in the salaries the amount of the general wage order.

The provisions relating to the Arbitration Court come into force on 17 April 1978 (the date of commencement of the Industrial Relations Amendment Act 1977).
