ORDER

1. Title and commencement—(1) This order may be cited as the Judicial Salaries Order (No. 2) 1981.

(2) This order shall be deemed to have come into force on the 11th day of June 1981.

2. Salaries of Judges—The salaries payable to the Judges of the Court of Appeal, the Judges of the High Court, the Judges of the Arbitration Court, the Judge of the Compensation Court, the Judges of the Maori Land Court, and the District Court Judges shall be paid at the respective rates set out in the Schedule to this order.

3. Revocation—The Judicial Salaries Order 1981* is hereby revoked.
