THE KINDERGARTEN REGULATIONS 1959 (REPRINT)

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

The Education Act 1914 has been repealed and replaced by the Education Act 1964.

REGULATIONS

- 1. Title—These regulations may be cited as the Kindergarten Regulations 1959.
- 2. Interpretation—In these regulations, unless the context otherwise

"Association" means a free kindergarten association formed for the purpose of establishing and maintaining a kindergarten or kindergartens:

"Kindergarten" means a free kindergarten controlled by an asso-

ciation and recognised by the Minister:

"Kindergarten Diploma" means a certificate issued in New Zealand by the New Zealand Free Kindergarten Union Incorporated certifying that the holder thereof is competent to carry out the duties of a kindergarten teacher, or any certificate or qualification issued in New Zealand or elsewhere which is recognised by the Director-General of Education as denoting an equivalent or higher standard:

"Kindergarten teacher" means any person employed on teaching duties in a kindergarten, or employed by an association in an educational capacity in connection with kindergartens in that association's area, or employed in a kindergarten training centre in connection with the training of kindergarten teachers:

"Kindergarten training centre" means a centre approved by the

Minister for the training of kindergarten teachers:

"Minister" means the Minister of Education:

"Salary order" means a determination by the Director-General of Education under the State Services Remuneration and Conditions of Employment Act 1969 in relation to the remuneration of members of the Education service:1

"School year" means the period of 12 months ending with the 31st

day of January in any year. "Kindergarten Diploma": The reference to the Director-General of Education was substituted for a reference to the Director of Education by s. 2 (2) (a) of the Education Act 1964.
"Salary order": The definition of this term was substituted for the original

definition by regulation 2 of S.R. 1973/16.

3. Recognition of kindergartens—(1) Any association may apply to the Minister for recognition of a free kindergarten under its control.

(2) The Minister, if he is of the opinion that the kindergarten is necessary and that the association is in a position to conduct it satisfactorily with such assistance as may be granted under these regulations, may, from a date prescribed in that behalf, approve the application and fix the initial grade of the kindergarten so recognised.

(3) No application under this regulation for the recognition of a kindergarten shall be approved in respect of a kindergarten which has less than a total of [50] children enrolled or about to be enrolled in its

morning and afternoon sessions.

(4) Unless the Minister otherwise decides, no application for recognition of a free kindergarten under this regulation shall be approved where the association making the application was not already controlling a kindergarten at the commencement of these regulations.

In subclause (3) the figures "50" were substituted for "60" by regulation 3 of S.R. 1973/16.

- 4. Withdrawal of recognition—The Minister, if he considers any kindergarten is not being conducted in a satisfactory manner or is of the opinion that the number of children enrolled or likely to be enrolled is insufficient to justify the continued recognition of the kindergarten, may withdraw any recognition given under regulation 3 of these regulations, and the provisions of these regulations shall thereupon cease to apply to that kindergarten.
- [5. Grading and staffing—(1) Each kindergarten shall be designated Grade O, Grade I, or Grade II, according to the number of children enrolled and such other considerations as the Minister may from time to time determine.

(2) A Grade O kindergarten shall have a Head Teacher and an untrained assistant, a Grade I kindergarten shall have a Head Teacher and one other teacher, and a Grade II kindergarten shall have a Head Teacher and 2 other teachers:

Provided that the Director-General of Education may on grounds of special circumstances approve in respect of any kindergarten the appointment of an additional teacher.]

This regulation was substituted for the original regulation 5 (as amended by regulation 2 of S.R. 1969/113) by regulation 4 (1) of S.R. 1973/16.

6. Determination of grade after initial year—(1) The grade of a kindergarten for any year after the initial year shall be determined by

[the Director-General of Education].

(2) If any association wishes to increase the number on the roll of a kindergarten during any term to such an extent as to warrant an alteration in the grade of that kindergarten and [the Director-General of Education] is satisfied that the increased number is likely to be maintained and that there is adequate accommodation for the increased number, he may approve of the alteration of the grade of the kindergarten from such date as he may specify.

In subclauses (1) and (2) the references to the Director-General of Education were substituted for references to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

7. Qualification for appointment of teacher—I Every person employed as a teacher in a kindergarten, other than an untrained assistant employed in a Grade O kindergarten in accordance with subclause (2) of regulation 5 of these regulations,] shall be the holder of a Kindergarten Diploma:

Provided that if a vacancy for the appointment of [a teacher (other than a Head Teacher)] exists and no person holding a Kindergarten Diploma is available for the vacancy, [the Director-General of Education] may consent to some other person being appointed to the vacancy until such time as the holder of a Kindergarten Diploma

becomes available for the position:

Provided also that where the position of [Head Teacher of a Kindergarten] has been held by the holder of a Kindergarten Diploma and the position becomes vacant, the vacancy may, with the consent of [the Director-General of Education], be filled by the appointment of [a Head Teacher] without a diploma for such time as [the Director-General of Education] may approve.

The words in the first set of square brackets were substituted for the words "Every teacher employed in a kindergarten" by regulation 5 of S.R.

8. Grants for salaries and allowances—[(1) Out of funds appropriated

by Parliament for the purpose—

- (a) Grants may be made to associations for the purpose of the payment of the salaries and allowances of kindergarten teachers employed by associations and the allowances of students undertaking training in kindergarten training centres controlled by associations:
- (b) Grants may be made to a Regional Council of Management (to which the control of a kindergarten training centre has passed in accordance with regulation 16A of these regulations) for the purpose of the payment of the salaries and allowances of kindergarten teachers employed in the training centre and the allowances of students undertaking training in the training

Provided that the amounts authorised to be paid to any association or Regional Council of Management under this subclause in respect of students undertaking training in kindergarten training centres shall be paid by the association or the Regional Council of Management, as the case may be, to each student concerned, subject to a condition that she attends regularly the classes provided for her training and makes satisfactory progress in her training.1

(2) The number of students undertaking training in each kindergarten training centre in respect of which payments under this regula-

tion are made in any year shall be determined by the Minister.

Subclause (1) was substituted for the original subclause (1) by regulation 2 of S.R. 1965/50.

9. Salaries and allowances of teachers and students—(1) Kindergarten teachers and students undertaking training in a kindergarten training centre shall be paid salaries and allowances in accordance with the appropriate salary order for the time being in force pertaining to such teachers and students:

Provided that any person employed as a part-time teacher in a kindergarten training centre and approved for that purpose by I the Director-General of Education shall be paid at such hourly rates as the association for Regional Council of Management controlling the training centre determines; but the grants paid to an association Cor Regional Council of Management under subclause (1) of regulation 8 of these regulations towards the reimbursement of payments made to any such teachers shall not be paid at a rate in excess of that approved by the Minister from time to time with the concurrence of the Minister of Finance.

(2) Except as otherwise provided in any such salary order or in these regulations and without restricting anything so provided, the conditions under which salaries and allowances shall be paid to kindergarten teachers and to students undertaking training in a kindergarten training centre shall from time to time be defined by I the Director-General of Education by notification in the Education Gazette or by notification to the teachers or students concerned.

In subclauses (1) and (2) the references to the Director-General of Education were substituted for references to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

In subclause (1) the words in the second and third sets of square brackets were inserted by regulation 3 of S.R. 1965/50.

- 10. Application of staffing and salary regulations to teachers—The provisions of regulations 9 and 10 of the Education (Salaries and Staffing) Regulations 1957* shall, with the necessary modifications, apply to kindergarten teachers as if they were teachers within the meaning of those regulations.
- 11. Leave of absence—Every kindergarten teacher and every student admitted for training to a kindergarten training centre shall be entitled to leave of absence in accordance with the provisions of the Teachers' Leave of Absence Regulations 1951.†
- 12. Conduct of kindergartens—I (1) Except where otherwise approved by the Director-General of Education, the minimum weekly schedule to be observed in kindergartens shall, subject to regulation 25 of these regulations, be made up as follows:

(a) A morning session of 3 hours for pupils on each of 5 days:

(b) An afternoon session of $2\frac{1}{2}$ hours for pupils on each of 3 of those

5 days:

(c) A period of at least $2\frac{1}{2}$ hours in the afternoon on each of the other 2 of those 5 days, of which periods one shall be reserved solely for work with parents and the other for maintenance and administration.

(2) Every kindergarten shall observe an interval of not less than one hour between the morning sessions and the afternoon sessions or periods

on any day,

(3) The weekly hours of duty of every teacher on the staff of a kindergarten shall include those of the minimum weekly schedule of that kindergarten and, in addition, the teacher shall be expected to be on duty for a reasonable period before each morning session and after each afternoon session for purposes of preparation of work, supervision of children, interviews with parents, and other purposes relevant to the efficient conduct of the kindergarten.

(4) Every kindergarten shall remain open for the purposes of subclause (1) of this regulation for not less than 380 half days in each

calendar year:

Provided that, if it is shown to the satisfaction of I the Director-General of Education I that the closing of a kindergarten is necessary owing to the prevalence of epidemics or other sufficient cause, he may approve of the kindergarten remaining open for a lesser number of half days.

In subclause (4), in the proviso, the reference to the Director-General of Education was substituted for a reference to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

13. Age for enrolling pupils—(1) Subject to the provisions of this regulation, any child who has attained the age of 3 years but who has not attained the age of 5 years may be enrolled as a pupil in a kindergarten:

Provided that a child who is enrolled as a pupil may remain so enrolled until the end of the school term in which he attains the age of

Provided also that, in special circumstances and with the approval of I the Director-General of Education I, any child may be enrolled or continue to be enrolled as a pupil in a kindergarten after attaining the age of 5 years, but in no case after attaining the age of 7 years.

(2) Any child who attains the age of $2\frac{1}{2}$ years but who has not attained the age of 3 years may be admitted to the afternoon kinder-

garten sessions:

Provided that not more than one-fifth of the total number of children admitted to afternoon kindergarten sessions shall be under the age of 3 years.

In subclause (1), in the second proviso, the reference to the Director-General of Education was substituted for a reference to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

- 14. No fee payable for attendance—No fee shall be payable in respect of the attendance of a child at a kindergarten.
- 15. No religious instruction to pupils—No religious instruction of a sectarian character shall be given at a kindergarten.
- 16. Training of teachers—(1) Any association approved by the Minister for the purpose may conduct a kindergarten training centre and admit students for training as kindergarten teachers.
- (2) The staff of a training centre shall consist of a principal, an assistant principal, and such full-time and part-time assistants as the Minister may approve.

(3) The syllabus of training at a training centre shall be approved

by the Director-General of Education.

(4) Every kindergarten training centre shall be open in each calendar

year for all students for not less than 380 half days:

Provided that, if it is shown to the satisfaction of I the Director-General of Education that the closing of the centre is necessary owing to the prevalence of epidemics or other sufficient cause, he may approve of the kindergarten remaining open for a lesser number of half days.

In subclauses (3) and (4) the references to the Director-General of Education were substituted for references to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

[16A. Regional Council of Management—(1) The Minister may, on the application of an association conducting a kindergarten training centre, direct by notice in the Gazette that for a period not exceeding 3 years from the date fixed in the notice the association shall cease to exercise control over the training centre and that the control shall pass to a Regional Council of Management.

- (2) Every such Regional Council of Management shall consist of—
- (a) The Principal of the teachers training college which is nearest to the kindergarten training centre, or his nominee:
- (b) The Head of the Department of Education in the University which is nearest to the kindergarten training centre, or his nominee:
- (c) Three members elected by the associations in the regional area, which regional area shall be such area as the Minister, after consultation with the New Zealand Free Kindergarten Union Incorporated, from time to time determines, by notice in the Education Gazette:

(d) Three members appointed by the Minister.

- (3) Any appointed or elected member of any such Regional Council may be at any time removed from office by the Minister for disability, bankruptcy, neglect of duty, or misconduct proved to the satisfaction of the Minister, or may at any time resign his office by writing addressed to the Minister:
- (4) If any appointed or elected member of any such Regional Council dies or resigns or is removed from office, his office shall become vacant and the vacancy so created shall be filled in the manner in which the appointment or election to the vacant office was originally made.
- (5) The powers of any such Regional Council shall not be affected by any vacancy in its membership.

16B. Conduct of proceedings of Regional Council of Management—(1) Every such Regional Council shall hold its meetings, elect a Chairman, appoint officers, and conduct its proceedings in such manner as it may determine.

(2) Every such Regional Council shall expend all money paid to it pursuant to these regulations for the purpose for which it is so paid.

- (3) Subject to the terms of any trust, all other money received by any such Regional Council shall be used in such manner as the Regional Council thinks fit for the purposes of the training centre under its control.
- (4) Any money received by or on behalf of any Regional Council of Management shall be paid forthwith into such bank within the meaning of the Banking Act 1908 as the Council may determine to the credit of a separate account in its name, and may be applied by the Council in the payment of the expenses incurred by the Council in the exercise of its functions under these regulations, including remuneration of kindergarten teachers and students and of any servants of the Council.
- (5) All cheques drawn on the said bank account shall be signed by any two of such members of the Council as are nominated for the purpose.
- (6) No cheque shall be drawn on the said account, and no money of the Council shall be expended, except pursuant to a resolution of the Council approving payment of the amount thereof, but no banker or other person to whom a cheque duly signed as aforesaid is presented shall be concerned to inquire whether any such resolution has been passed.

[16c. Extension of period of control by Regional Council of Management—(1) At the end of any period for which the control of a kindergarten training centre has, in accordance with regulation 16A of these regulations, passed to a Regional Council of Management, the Minister may, with the concurrence of the association which was the former controlling authority of the kindergarten training centre, direct by notice in the Gazette that the control of the kindergarten training centre shall be retained by the Regional Council of Management for a further period not exceeding 3 years.

(2) Except where in accordance with subclause (1) of this regulation the Minister otherwise directs, a Regional Council of Management shall, on the expiry of any period for which the control of a kindergarten training centre has passed to it, cease to exercise control over the kindergarten training centre; and the control of the kindergarten training centre shall then vest in the association which was the former con-

trolling authority of that centre.

Regulations 16a, 16b, and 16c were inserted by regulation 4 of S.R. 1965/50.

I17. Qualifications for entry to training—(1) A candidate for training as a kindergarten teacher shall have the following qualifications and shall comply with the following requirements.

shall comply with the following requirements:

(a) She shall, if she does not possess an educational qualification accepted by the Director-General of Education as being higher than the minimum qualification required for the time being under paragraph (b) of this subclause, be not less than 17 years of age on the last day of February in the year in which she commences her course of training:

- (b) She shall have attained in the School Certificate Examination in any year the standard of success prescribed by subclause (2) of this regulation or possess equivalent or superior educational qualifications or possess such other educational qualifications as may be accepted as sufficient by the Director-General of Education from time to time:
- (c) She shall furnish to the selection committee for the training centre she wishes to attend:
 - (i) Such evidence as the Director-General of Education may require that she is free from any physical or other defect incompatible with effective work as a kindergarten teacher; and
 - (ii) Two satisfactory testimonials (one of which shall be preferably from the head teacher of the school that she last attended) as to her character and personality:
- (d) She shall sign such declaration of intention to teach for a specified period after the completion of training as the Minister may require for entrants to a kindergarten training centre.
- (2) For the purposes of paragraph (b) of subclause (1) of this regulation, a candidate shall attain the required standard of success in the School Certificate Examination if in any year she obtains not less than 30 percent of the total possible marks in English and—

(a) In any four subjects of the examination (of which English may

be one), she obtains—

(i) An aggregate of at least 180 marks, but with not less

than 50 percent of the total possible marks in each of three

of the subjects; or

(ii) Not less than 50 percent of the total possible marks in each of two of the subjects and not less than 40 percent of the total possible marks in each of the other two subjects; or

(b) In any 5 subjects of the examination (of which English may be one), she obtains an aggregate of not less than 225 marks: Provided that, where in any year a candidate has obtained not less than 30 percent of the total possible marks in any subject of the School Certificate Examination the marks so obtained shall, for the purpose of determining the standard of success attained by the candidate in the School Certificate Examination in any subsequent year, be deemed to have been obtained by the candidate in the subject in that subsequent year.

(3) For the purposes of subclause (2) of this regulation, a candidate who has been granted an aegrotat pass in any subject of the School Certificate Examination, being a pass of Grade A or Grade B or Grade C, shall be deemed to have obtained the minimum percentage of the total possible marks in that subject which a candidate, sitting the examination in the subject, would require in order to obtain the same

grade of pass.

- 18. Committee for selection of students—(1) For the purpose of selecting students for training at a training centre, the association for Regional Council of Management in control thereof may appoint for the training centre a committee of not less than 3 persons, one of whom shall be the Principal of the training centre.
- (2) All persons appointed to a committee under this regulation, other than the Principal of the training centre, shall be approved by I the Director-General of Education.

In subclause (1) the words in square brackets were inserted by regulation 5 of S.R. 1965/50.

In subclause (2) the reference to the Director-General of Education was substituted for a reference to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

19. Travelling allowances for students—There shall be paid out of money appropriated by Parliament for the purpose to each association and Regional Council of Management in respect of each student who is required to travel daily in order to undertake her training, travelling allowances at such rates and on such conditions as the Minister may from time to time determine with the concurrence of the Minister of Finance.

The words in square brackets were inserted by regulation 6 of S.R. 1965/50.

20. Medical examination of students—Every student at a kindergarten training centre shall when required by I the Director-General of Education I submit to examination by a School Medical Officer, and to such

further medical examination as the School Medical Officer considers necessary.

The reference to the Director-General of Education was substituted for a reference to the Director of Education by s. 2 (2) (a) of the Education Act 1964.

21. Termination of training of a student—(1) With the concurrence of the Director-General of Education the course of training of a student may be terminated for any of the following reasons:

(a) If the Principal of a training centre reports that the student has not after reasonable trial shown sufficient promise of suitability

for kindergarten teaching; or

(b) If a School Medical Officer reports or other medical evidence reveals that the health of the student is such as to render her unfit for the work of kindergarten teaching; or

(c) If the student marries before completing such period of her training as the Minister may from time to time determine; or

(d) If the Principal reports that the student's conduct, diligence,

and attention to study are unsatisfactory; or

(e) If it should become known to an association of a Regional Council of Management that the student does not intend to render teaching service in a kindergarten at the completion of her period of training as provided for in the declaration of intention to teach signed by her in accordance with paragraph (d) of regulation 17 of these regulations.

(2) For immorality, wilful disobedience, or gross misbehaviour a student at a training centre shall be liable to suspension and may, after due inquiry by the controlling authority of the training centre, be dismissed without claim on the association for the Regional Council of Management, as the case may be, I if adjudged guilty of such conduct.

(3) Where a studentship is terminated under paragraph (d) or paragraph (e) of subclause (1), or under subclause (2), of this regulation or by resignation, all fees and allowances paid in respect of the studentship shall, unless the Minister otherwise directs, constitute a debt due from the student to the Crown and shall be recoverable accordingly in a Court of competent jurisdiction.

In subclauses (1) (e) and (2) the words in square brackets were inserted by regulation 7 (a) and (b) respectively of S.R. 1965/50.

22. Subsidies for sites, buildings, furniture, and equipment—There may be paid out of money appropriated by Parliament for the purpose and on such conditions as the Minister may deem appropriate—

(a) Subsidies not exceeding [[\$41] for every [[\$2]] of voluntary contributions raised by an association and expended with the approval of the Minister on sites, buildings, furniture, or

equipment for kindergartens:

(b) Subsidies not exceeding [[\$41]] for every [[\$2]] of voluntary contributions raised by an association or by a Regional Council of Management having control of a kindergarten training centre and expended with the approval of the Minister on furniture or equipment for a kindergarten training centre:

(c) The money required for the provision of sites and buildings for kindergarten training centres approved by the Minister.

- 23. General—(1) Each association Land each Regional Council of Management having control of a kindergarten training centre shall keep full and true accounts and shall cause its accounts for each school year to be balanced and true statements to be prepared showing-
 - (a) All money received and paid during the year;

(b) The income and expenditure for the year;

(c) The assets and liabilities at the end of the year.

(2) All such accounts and statements shall be audited by some competent person and shall be open to inspection by an officer of the Department of Education and copies of the statement shall be sent to I the Director-General of Education within 3 months of the close of the school year.

In subclause (1) the words in square brackets were inserted by regulation 9 of S.R. 1965/50.

- 24. Returns of teachers salaries—Each association Land each Regional Council of Management having control of a kindergarten training centre shall forward to the Director-General of Education returns relating to the payment of the salaries of kindergarten teachers at such times and in such manner as he may require.

25. Closing days for kindergartens—(1) All kindergartens shall be closed on the following days:

Anzac Day:

The day appointed for observance of the birthday of the reigning Sovereign:

Labour Day (the fourth Monday in October):

Anniversary Day of the province.

(2) In addition to the days listed in subclause (1) an association may close a kindergarten on such special occasions as it may in its discretion decide but not so that the total number of half days when the kindergarten is open in any calendar year is less than provided for in subclause (4) of regulation 12 of these regulations.

The 6th of February in each year is also to be observed as a public holiday; see s. 3 of the New Zealand Day Act 1973.

- 26. New Zealand Free Kindergarten Union—The New Zealand Free Kindergarten Union Incorporated shall be recognised by the Minister as representing all associations in the discussion of all matters relating to kindergarten policy.
- 27. Revocations—(1) The regulations specified in the Schedule hereto are hereby revoked.
- (2) Without limiting the provisions of the Acts Interpretation Act 1924, it is hereby declared that the revocation of any provision by these regulations shall not affect any document made or any thing whatsoever done under the provision so revoked or under any corresponding former provision, and every such document or thing, so far as it is subsisting or in force at the time of the revocation and could have been made or done under these regulations, shall continue and have effect as if it had been made or done under the corresponding provision of these regulations and as if that provision had been in force when the document was made or the thing was done.
