THE LEGAL AID REGULATIONS 1970, AMENDMENT NO. 6

ORDER IN COUNCIL

At the Government Buildings at Wellington this 13th day of December 1982

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to section 38 (ca) of the Legal Aid Act 1969, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Legal Aid Regulations 1970, Amendment No. 6, and shall be read together with and deemed part of the Legal Aid Regulations 1970* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Assessment of disposable income—The principal regulations are hereby amended by revoking regulation 10B (as substituted by regulation 2 of the Legal Aid Regulations 1970, Amendment No. 5), and substituting the following regulation:

"10B. The amounts that may be deducted in calculating an applicant's disposable income under section 19 of the Act in respect of the items specified in the Schedule to the Act are as follows:

"1. A personal allowance: \$5,604:

"2. An allowance where the resources of any other person are treated as the applicant's resources under any of the provisions of subsections (6), (7), and (8) of section 19 of the Act: \$2,869.

- "3. An allowance—
- "(a) In the case of a married person, for a dependent child or a dependent relative (not being the person's spouse): \$312 for each child or dependent relative:
- "(b) In the case of an unmarried person, for a dependent child or a dependent relative: \$2,557 for the first child or dependent relative: \$312 for each additional child or dependent relative."

3. Revocation—The Legal Aid Regulations 1970, Amendment No. 5 are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 increases the amounts to be deducted from the income of an applicant for legal aid in determining the applicant's disposable income for the purposes of the Legal Aid Act 1969.
