PURSUANT to section 12 (4) of the Local Authorities (Petroleum Tax) Act 1970, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title—This order may be cited as the Local Authorities (Petroleum Tax) Representation Order 1971.

2. Representation of constituent districts on administering committees of certain tax areas—The Second Schedule to the Local Authorities (Petroleum Tax) Act 1970 is hereby amended by revoking so much thereof as relates to items 6 (Wanganui), 8 (East Coast), 13 (Marlborough), and 14 (West Coast), and substituting, in their appropriate numerical order, the items set out in the Schedule hereto.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order alters the representation on administering committees under the Local Authorities (Petroleum Tax) Act 1970 of the constituent districts of the Wanganui, East Coast, Marlborough, and West Coast tax areas.

The new representation in each case is set out in the Schedule to the order.

The order is made to give effect to joint recommendations made to the Minister of Internal Affairs, under section 12 of the Act, by the constituent local authorities of each of the above-mentioned tax areas.
