

THE LOCAL GOVERNMENT (LOCAL AUTHORITIES SALARIES AND ALLOWANCES) DETERMINATION 1992

PURSUANT to section 101zzr of the Local Government Act 1974 (as inserted by section 15 (1) of the Local Government Amendment Act (No. 2) 1989), the Minister of Local Government, acting with the consent of the Minister of Forestry, hereby makes the following determination.

DETERMINATION

- 1. Title and commencement—(1) This determination may be cited as the Local Government (Local Authorities Salaries and Allowances) Determination 1992.
- (2) Except as provided in subclauses (3) and (4) of this clause, this determination shall be deemed to have taken effect on and from the 1st day of January 1992.
- (3) Clause 8 of this determination shall take effect on and from the 10th day of October 1992.
- (4) The following provisions of the Schedule to this determination, namely,—
 - (a) Paragraph 4 of Part I; and
 - (b) Paragraph 4 of Part II; and
 - (c) Paragraph 4 of Part III,—
- shall take effect on and from the 10th day of October 1992.

2. Interpretation—(1) In this determination, unless the context otherwise requires,—

"Act" means the Local Government Act 1974:

- "Board" means, subject to subclause (2) of this clause,—
 - (a) The Marlborough Forestry Corporation:
 - (b) The Masterton Trust Lands Trust:
 - (c) The Selwyn Plantation Board.
- (2) As from the commencement of the 10th day of October 1992, the term "board" includes, in addition to the local authorities specified in paragraphs (a) to (c) of the definition of that term in subclause (1) of this clause, the Auckland Regional Services Trust.
- (3) Unless the context otherwise requires, terms used in this

determination have the same meaning as in the Act.

- 3. Maximum salaries of Chairpersons—The maximum salary payable pursuant to Part IVc of the Act to the Chairperson of a board shall be the maximum salary applicable under Part I of the Schedule to this determination.
- 4. Maximum salaries of members of boards—The maximum salary payable pursuant to Part IVc of the Act to a member of a board shall be the maximum salary applicable under Part II of the Schedule to this determination.
- One salary only payable—The payment by a board of the salaries referred to in section 101zzr of the Act is subject to the condition that the local authority shall not pay to a person more than one of those salaries.
- 6. Maximum meeting allowances to members of boards—The maximum meeting allowance payable pursuant to Part IVc of the Act to each member of a board (other than its Chairperson) shall be the maximum meeting allowance applicable under Part III of the Schedule to this determination.
- 7. Conditions in relation to payment of meeting allowances to members of board—The payment of a meeting allowance to a member of a board (other than its Chairperson) is subject to the following conditions:
 - (a) The board shall pay a meeting allowance to a member of the board only in respect of a day on which the member of the board attends-
 - (i) A meeting of the board; or
 - (ii) A meeting of a committee of the board where the member of the board is a member of the committee or is required to attend the meeting in his or her capacity as a member of the board:
 - (b) The board shall pay only one meeting allowance under clause 6 of this determination to a person in respect of any one day, notwithstanding that that person attends more than one meeting (being a meeting of the board or of a committee of the board) on that day:
 - meeting that continues past midnight otherwise than by adjournment shall be regarded as having concluded before midnight.

- 8. Conditions in relation to payment of meeting allowances to members of Auckland Regional Services Trust—The payment of a meeting allowance to a member of the Auckland Regional Services Trust (other than its Chairperson) is subject both to the conditions set out in paragraphs (a) to (c) of clause 7 of this determination and to the condition that the maximum number of meeting allowances that the Auckland Regional Services Trust may pay to a member of the Auckland Regional Services Trust in respect of meetings attended by that member in any period of 12 months (beginning on the 1st day of January) shall be 12.
- **9. Minimum salaries and minimum meeting allowances**—(1) The minimum salary payable pursuant to Part IVc of the Act in respect of each of the positions referred to in clauses 3 and 4 of this determination shall be in each case an annual salary equal to 10 percent of the maximum annual salary applicable.

(2) The minimum meeting allowance payable pursuant to Part IVc of the Act to each member of a board (other than its Chairperson) shall be a meeting allowance equal to 10 percent of the maximum meeting allowance applicable.

- 10. Meeting allowances for members of committees who are not members of board—(1) The meeting allowances payable to any person who is a member of a committee of a board but who is not a member of the board shall be the same as those that would be payable to that person if he or she were a member of the board.
- (2) Nothing in this clause limits the provisions of section 101zzc of the Act.
- 11. **Revocation**—The Local Government (Local Authorities Salaries and Allowances) Determination 1991* is hereby revoked.

EXPLANATORY NOTE

This note is not part of the determination, but is intended to indicate its general effect. This determination—

- (a) Fixes, on and from 1 January 1992, the maximum and minimum annual salaries that may be paid to-
 - (ii) The Chairperson of the Marlborough Forestry Corporation:
 (ii) The Chairperson of the Masterton Trust Lands Trust:

 - (iii) The Chairperson of the Selwyn Plantation Board:
 - (iv) Any member of the Marlborough Forestry Corporation:
 - (v) Any member of the Masterton Trust Lands Trust:
 - (vi) Any member of the Selwyn Plantation Board:
- (b) Fixes, on and from 1 January 1992, the maximum and minimum meeting allowances payable to each member (other than the Chairperson) of the Marlborough Forestry Corporation or the Masterton Trust Lands Trust or the Selwyn Plantation Board:
- (c) Provides, on and from 1 January 1992, for the payment of meeting allowances to any member of a committee of the Marlborough Forestry Corporation or the Masterton Trust Lands Trust or the Selwyn Plantation Board who is not a member of the Corporation or the Trust or the Board.

The rates of remuneration payable to members of the bodies specified in paragraphs (a) to (c) above are not altered.

In the case of the Auckland Regional Services Trust, the determination-

- (a) Fixes, on and from 10 October 1992, the maximum and minimum salaries that may be paid to the Chairperson of the Auckland Regional Services Trust:
- (b) Fixes, on and from 10 October 1992, the maximum and minimum meeting allowances payable to each member (other than the Chairperson) of the Auckland Regional Services Trust:
- (c) Provides, on and from 10 October 1992, for the payment of meeting allowances to any member of a committee of the Auckland Regional Services Trust who is not a member of the Trust.
