



## THE LOCAL GOVERNMENT (AREA HEALTH BOARDS ANNUAL ALLOWANCES AND REMUNERATION) DETERMINATION 1986

PURSUANT to section 214B of the Local Government Act 1974, the Minister of Local Government (having due regard to the changes in certain annual allowances determined by the Higher Salaries Commission in a determination dated the 22nd day of July 1986 and made under section 214A of the Local Government Act 1974 and such other matters as the Minister considers relevant), and acting with the consent of the Minister of Health, hereby makes the following determination.

### DETERMINATION

**1. Title and commencement**—(1) This determination may be cited as the Local Government (Area Health Boards Annual Allowances and Remuneration) Determination 1986.

(2) This determination shall take effect on and from the 1st day of September 1985 (being the date on and from which the determination of the Higher Salaries Commission dated the 22nd day of July 1986 takes effect).

**2. Interpretation**—In this determination, unless the context otherwise requires,—

“Act” means the Local Government Act 1974:

“Board” means an area health board constituted under the Area Health Boards Act 1983:

“Committee” means any committee appointed under section 28 of the Area Health Boards Act 1983.

**3. Annual allowances of Chairmen**—(1) A Board may pay to the Chairman of the Board an annual allowance not exceeding that specified in respect of that Board in Part I of the First Schedule to this determination.

(2) By virtue of section 214B(1)(a) of the Act, nothing in this clause applies in respect of the Chairman of the Northland Area Health Board whose annual allowance has been determined by the Higher Salaries Commission under section 214A of the Act.

**4. Annual allowances of chairmen of standing committees**—A Board may pay to each person who is the chairman of any standing committee appointed by it (other than the Chairman of the Board) an annual allowance not exceeding that specified in respect of that Board in Part II of the First Schedule to this determination.

**5. Remuneration of members**—(1) Subject to subclause (2) of this clause and clause 6 of this determination, a Board may pay to each of its members (other than the Chairman of the Board or a member who is entitled to receive an allowance under clause 4 of this determination) remuneration not exceeding that specified in Part III of the First Schedule to this determination in respect of each day on which the person attends a meeting of the Board or a committee of the Board either as a member or, in the case of a committee of which the person is not a member, as a person who is required to attend in the person's capacity as a member of the Board.

(2) The remuneration that may be paid under the authority of subclause (1) of this clause shall not be paid to any person in respect of more than 104 days in any calendar year.

**6. Application of daily remuneration**—In determining the remuneration payable to any person who is a member of a Board—

- (a) Remuneration may be paid only once in respect of any one day (being a period of 24 hours beginning at midnight) irrespective of the number of meetings attended by the person on that day;
- (b) Where a meeting is adjourned to a subsequent day or days, remuneration may be paid in respect of each day on which the meeting is held;
- (c) A meeting that continues past midnight shall be deemed to have concluded before midnight.

**7. Higher Salaries Commission determination**—The determination of the Higher Salaries Commission dated the 22nd day of July 1986, being a relevant current determination of that Commission preceding this determination, is set out in the Second Schedule to this determination as required by section 214B(5)(a) of the Act.

EXPLANATORY NOTES

Determinations and their effect

- (a) The Commission determines remuneration in relation to the responsibilities of each office and not in relation to the personal performances of individuals. Unless otherwise specified in a determination, it applies both to the present incumbent and to any replacement.
- (b) In terms of Section 214A of the Local Government Act, the Higher Salaries Commission is empowered to determine the actual or maximum annual allowance.

Maximum Allowance: Where the Commission has determined a maximum allowance the authority retains the responsibility and the right, within the limits prescribed by the Commission, to exercise its own discretion to fix from time to time the actual allowance to be paid to the individual.

Actual Allowance: Where the Commission has determined the actual allowance and has not specified it as a maximum, then the authority must not pay an allowance that is either more or less than the amount stated.

## EXPLANATORY NOTE

*This note is not part of the determination, but is intended to indicate its general effect.*

This determination fixes the maximum allowances and remuneration that may be paid to Chairmen, chairmen of standing and special committees, and members of Area Health Boards. The determination does not apply to the Chairman of the Northland Area Health Board whose annual allowance was determined by the Higher Salaries Commission in the determination set out in the Second Schedule to this determination.

The determination takes effect on and from 1 September 1985 and fixes the maximum annual allowances and remuneration payable on and from that date. The actual allowances and remuneration payable up to those maxima are to be set by each Board.
