

## THE LOCAL GOVERNMENT (AUCKLAND REGIONAL SERVICES TRUST SALARIES AND ALLOWANCES) DETERMINATION 1996

PURSUANT to section 101zzr of the Local Government Act 1974 (as inserted by section 15 (1) of the Local Government Amendment Act (No. 2) 1989), the Minister of Local Government hereby makes the following determination.

## DETERMINATION

- 1. Title and commencement—(1) This determination may be cited as the Local Government (Auckland Regional Services Trust Salaries and Allowances) Determination 1996.
- (2) This determination shall take effect on and from the 1st day of November 1996.
- 2. Interpretation—(1) In this determination, unless the context otherwise requires,—
  - "the Act" means the Local Government Act 1974:
  - "Trust" means the Auckland Regional Services Trust.
- (2) In this determination, unless the context otherwise requires, terms have the same meaning as in the Act.
- **3. Maximum salary of Chairperson**—The maximum salary payable pursuant to Part IVc of the Act to the Chairperson of the Trust shall be \$50,000 per annum.
- **4. Maximum salary of Deputy Chairperson**—The maximum salary payable pursuant to Part IVC of the Act to the Deputy Chairperson of the Trust shall be \$20,000 per annum.

- **5. Maximum salaries of members**—The maximum salary payable pursuant to Part IVc of the Act to a member of the Trust shall be \$15,000 per annum.
- **6.** One salary only payable—The payment of the salaries referred to in clauses 3, 4, and 5 of this determination is subject to the condition that no person is to be paid more than one of those salaries.
- **7. Maximum meeting allowances to members of Trust**—The maximum meeting allowance payable pursuant to Part IVc of the Act to each member of the Trust (other than its Chairperson but including the Deputy Chairperson) shall be \$150 per meeting.
- 8. Conditions in relation to payment of meeting allowances to members of Trust—The payment of a meeting allowance to a member of the Trust (other than its Chairperson but including the Deputy Chairperson) is subject to the following conditions:
  - (a) The meeting allowance payable to a member of the Trust shall be payable only in respect of a day on which the member of the Trust attends—
    - (i) A meeting of the Trust; or
    - (ii) A meeting of a committee of the Trust where the member of the committee is required to attend the meeting in his or her capacity as a member of the Trust:
  - (b) Only one meeting allowance under clause 7 of this determination shall be payable to a person in respect of any one day, notwithstanding that that person attends more than one meeting (being a meeting of the Trust or of a committee of the Trust) on that day:
  - (c) A meeting that continues past midnight otherwise than by adjournment shall be regarded as having concluded before midnight.
- 9. Minimum salaries and minimum meeting allowances—(1) The minimum salary payable pursuant to Part IVC of the Act in respect of each of the positions referred to in clauses 3, 4, and 5 of this determination shall be in each case an annual salary equal to 10 percent of the maximum annual salary applicable.
- (2) The minimum meeting allowance payable pursuant to Part IVC of the Act to each member of the Trust (other than its Chairperson but including the Deputy Chairperson) shall be a meeting allowance equal to 10 percent of the maximum meeting allowance applicable.
- 10. Consequential amendments—(1) Clause 2 of the Local Government (Local Authorities Salaries and Allowances) Determination 1996\* is hereby amended by omitting paragraph (b) from the definition of the term "Board".
- (2) The Fifth Schedule to the Local Government (Local Authorities Salaries and Allowances) Determination 1996\* is hereby amended by omitting from Parts I, II, and III of that Schedule the items relating to the Auckland Regional Services Trust.

## EXPLANATORY NOTE

This note is not part of the determination, but is intended to indicate its general effect.

This determination, which takes effect on and from 1 November 1996, fixes the maximum and minimum salaries of the Chairperson, Deputy Chairperson, and members of the Auckland Regional Services Trust. The determination also fixes the maximum and minimum meeting allowance payable to members of the Trust, and specifies certain conditions about the payment of meeting allowances.

The maximum and minimum annual salaries payable to the Chairperson and members of the Trust and the maximum and minimum meeting allowances payable to members of the Trust were previously fixed by the Local Government (Local Authorities Salaries and Allowances) Determination 1996. The maximum and minimum annual salaries payable to the Deputy Chairperson are new.

The maximum annual salary payable to the Chairperson of the Trust is increased from \$34,170 to \$50,000.

The maximum annual salary payable to the Deputy Chairman of the Trust is fixed at \$20,000.

The maximum annual salary payable to a member of the Trust is increased from \$12,850 to \$15,000.

The maximum meeting allowance payable to members of the Trust (other than the Chairperson) is increased from \$65 to \$150.
