THE LAKES ORAKAI, TUTIRA, AND WAIKOPIRO WILDLIFE REFUGE ORDER 1973

A PROCLAMATION

PURSUANT to the Wildlife Act 1953, I, Sir Edward Denis Blundell, the Governor-General of New Zealand, acting on the joint recommendation of the Minister of Internal Affairs, and the Minister of Lands and the Minister of Transport (being the Ministers charged with the administration of the Departments of State having the control of the land of the Crown affected by this proclamation), hereby proclaim as follows:

1. Title and commencement—(1) This Proclamation may be cited as the Lakes Orakai, Tutira, and Waikopiro Wildlife Refuge Order 1973.

(2) This Proclamation shall come into force on the day after the date of its notification in the *Gazette*.

2. Wildlife refuge declared—The area described in the First Schedule to this Proclamation (hereinafter referred to as the refuge) is hereby declared to be a wildlife refuge for the purposes of the Wildlife Act 1953.

3. Use of boats—Except with the prior written authority of the Secretary for Internal Affairs and subject to compliance with any conditions that the Secretary may impose, no person shall use any boat in Lake Tutira that is propelled by any means other than sails, oars, or paddles.

4. Revocations—The following Proclamations are hereby revoked: (a) Proclamation made on the 5th day of March 1957* declaring the land described in the Second Schedule to this proclama-

tion to be a wildlife refuge:

(b) Proclamation made on the 29th day of January 1963[†] declaring certain restrictions as to the use of boats in Lake Tutira.

SCHEDULES

FIRST SCHEDULE

HAWKE'S BAY LAND DISTRICT-HAWKE'S BAY COUNTY

SECTIONS 22, 23, and 24, Block XII Maungaharuru Survey District and Tutira B7 and B19 situated in Block XII, Maungaharuru Survey District; area 219.8796 hectares, more or less. (S.O. 5343, M.L. 1711^L).

As the same is more particularly shown on a plan marked I.A. Wil 34/6/3 deposited in the Head Office, Department of Internal Affairs, Wellington, and thereon edged red.

SECOND SCHEDULE

LAKES Waikopiro and Orakai, and that part Lake Tutira excluding Tutira B 19 Block together with the reserve under Section 129, Land Act 1924, surrounding Lake Orakai, and along parts of Lakes Tutira and Waikopiro. Also sections 12 and 15, Horse Paddock, and part of the Napier-Gisborne via Hangaroa State Highway, situated in Block XIII, Maungaharuru Survey District. As the same is more particularly shown on plan marked I.A. 52/20 deposited in the Head Office, Department of Internal Affairs, Wellington, and thereon edged red.
