ORDER

1. Title and commencement—(1) These regulations may be cited as the Land Transport (Offences and Penalties) Amendment Regulations (No. 2) 1999, and are part of the Land Transport (Offences and Penalties) Regulations 1999* ("the principal regulations").

(2) These regulations come into force on 25 October 1999.

2. Amendments to Schedule 1—Schedule 1 of the principal regulations is amended by omitting the provisions, brief descriptions, penalties, and infringement fees specified in the Schedule relating to the Land Transport Rule described in that schedule as "Glazing 1996 (32012)", and substituting the provisions, brief descriptions, penalties, and infringement fees specified in the Schedule of these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 25 October 1999, amend Schedule 1 of the Land Transport (Offences and Penalties) Regulations 1999. These amendments are a consequence of the making of the Land Transport Rule: Glazing, Windscreen Wipe and Wash, and Mirrors 1999, which comes into force on 25 October 1999.

The new rule expands the list of persons with responsibilities under the rule. In addition to operators, repairers, and certifiers, which were listed in the previous version of the rule, the list now includes modifiers, manufacturers, and retailers. These regulations specify the maximum penalties for each class of offences involving a breach of a provision under the new rule.
