PURSUANT to the Land Transfer Act 1952, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Land Transfer Regulations 1966, Amendment No. 1, and shall be read together with and deemed part of the Land Transfer Regulations 1966* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of December 1967.

2. Fees—The principal regulations are hereby amended by revoking the First Schedule, and substituting the First Schedule set out in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations substitute a new scale of fees expressed in decimal currency. The only changes are an increase from \$6 to \$8 in the fees payable for the registration of a transfer where the consideration exceeds \$2,000 or the registration of a mortgage where the principal sum exceeds \$2,000.
