HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Harbours Act 1950, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Lake Taupo Regulations 1976, Amendment No. 10, and shall be read together with and deemed part of the Lake Taupo Regulations 1976* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1991.

4. Fourth Schedule amended—The Fourth Schedule to the principal regulations (as so substituted) is hereby amended by omitting the words "One-twelfth of the appropriate annual fee", and substituting the expression "\$43".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1991, restructure the fees payable for berths under the Lake Taupo Regulations 1976. Overall, the fees payable in respect of berths have been reduced. Other fees payable under the regulations remain unchanged.
