

THE LAKE TAUPO REGULATIONS 1976, AMENDMENT NO. 8

ORDER IN COUNCIL

At Wellington this 29th day of May 1989

THE RIGHT HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Lake Taupo Regulations 1976, Amendment No. 8, and shall be read together with and deemed part of the Lake Taupo Regulations 1976* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 1st day of July 1989.
- 2. Harbourmaster and wardens—(1) Regulation 4 of the principal regulations is hereby amended by revoking subclause (4) (as amended by regulation 2 (2) of the Lake Taupo Regulations 1976, Amendment No. 2), and substituting the following subclause:

- "(4) The Regional Manager of the Rotorua Office of the Department of Internal Affairs may from time to time appoint any suitable person (whether or not an employee of the public service) to be a warden, either paid or honorary, as that manager thinks fit, to hold the office until the soonest of-
 - "(a) The expiration of a period (not exceeding 3 years) from the date of the person's appointment specified in that behalf by that manager at the time of the appointment:

"(b) The person's dismissal from the office:

"(c) The person's resignation of the office;—

but any warden may from time to time be reappointed."

- (2) Regulation 2 (2) of the Lake Taupo Regulations 1976, Amendment No. 2 is hereby consequentially revoked.
- 3. Private moorings—(1) Regulation 9 (4) of the principal regulations is hereby amended by omitting the expression "\$40" (as substituted by regulation 2 of the Lake Taupo Regulations 1976, Amendment No. 6), and substituting the expression "\$57".

(2) Regulation 2 of the Lake Taupo Regulations 1976, Amendment No. 6

is hereby consequentially revoked.

4. Survey fees—The principal regulations are hereby amended by

inserting, after regulation 18, the following regulation:

- "18A. Whenever a vessel is surveyed under regulation 17 (2) or regulation 18 (3) of these regulations, the owner shall pay a survey fee calculated at the rate per hour specified in the Third Schedule to these regulations for the time spent on the survey by the Harbourmaster or any other employee of the Department of Internal Affairs."
- 5. New Schedules substituted—The principal regulations are hereby amended by revoking the Schedules (as substituted by regulation 3 of the Lake Taupo Regulations 1976, Amendment No. 7), and substituting the schedules set out in the Schedule to these regulations.
- **6. Fees include GST**—The fees specified in the schedules to the principal regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
- 7. Revocations—The Lake Taupo Regulations 1976, Amendment No. 7 are hereby consequentially revoked.

"FIRST SCHEDULE

"ANNUAL FEES (INCLUDING GST)

- 1. Fees for use of moorings provided by Harbourmaster—Either \$525 or an amount calculated at a rate of \$22 per 300 mm or part thereof of the length of the craft to be moored, calculated on the basis of the overall length of the craft including all permanent extrusions, whichever is the greater.
- 2. Fees for mooring sites—Either \$334 or an amount calculated at a rate of \$9.50 per 300 mm or part thereof of the length of the craft to be

moored at the site, calculated on the basis of the overall length of the craft including all permanent extrusions, whichever is the greater.

- 3. Fee for permit to use launching ramps and similar facilities controlled by the Secretary—\$119 per craft.
 - 4. Fees for berths at wharves, jetties, and breastworks—
 - (a) At floating jetty, Tokaanu tailrace marina—\$428:
 - (b) At Motuoapa Marina-
 - (i) Bow-in berths at jetties—\$83 per 300 mm or part thereof of berth:
 - (ii) Bow-in other shoreside berths—\$60 per 300 mm or part thereof of berth:
 - (iii) Bow-in lakeside berths—\$44 per 300 mm or part thereof of berth:
 - (c) At Taupo Landing Reserve—
 - (i) Parallel berth—\$44 per 300 mm or part thereof of berth:
 - (ii) Bow in berth (not at jetty)—\$105 per 300 mm or part thereof of berth:
 - (iii) Bow-in berth (at jetty)—\$111 plus \$99 per 300 mm or part thereof of berth:
 - (d) Parallel berth elsewhere—\$37 per 300 mm or part thereof of berth:
 - (e) Bow-in berth elsewhere—\$74 per 300 mm or part thereof of berth.
 - 5. Fees for licences for commercial vessels—
 - (a) Vessels surveyed to carry fewer than 7 passengers—\$344:
 - (b) Vessels surveyed to carry more than 6 and fewer than 13 passengers—\$428:
 - (c) Vessels surveyed to carry more than 12 and fewer than 25 passengers—\$516:
 - (d) Vessels surveyed to carry more than 24 and fewer than 37 passengers—\$599:
 - (e) Vessels surveyed to carry more than 36 and fewer than 61 passengers—\$688:
 - (f) Vessels surveyed to carry more than 60 passengers—\$688, plus \$8.50 per passenger in excess of 60.
 - 6. Fees for licences for rental vessels—
 - (a) Power-driven vessels—\$141:
 - (b) Other vessels—
 - (i) Vessels surveyed to carry only 1 passenger—\$44:
 - (ii) Vessels surveyed to carry only 1 or 2 passengers—\$60:
 - (iii) Vessels surveyed to carry more than 2 and fewer than 8 passengers—\$74:
 - (iv) Vessels surveyed to carry more than 7 and fewer than 12 passengers—\$216:
 - (v) Vessels surveyed to carry more than 11 passengers—\$284.

"SECOND SCHEDULE

"Fees for Periods of Less than one Year (Including GST)

- 1. Fees for permit to use moorings provided by Harbourmaster—
- (a) \$10 per craft for a permit valid for one day:
- (b) \$42 per craft for a permit valid for one week:
- (c) Either \$86 or \$3.50 per 300 mm or part thereof of the length of the craft to be moored calculated on the basis of its overall length including all permanent extrusions, whichever is the greater, for a permit valid for one month.
- 2. Fees for permit to use launching ramps and similar facilities controlled by Secretary—
 - (a) \$8.50 per craft for a permit valid for one day:
 - (b) \$21 per craft for a permit valid for one week:
 - (c) \$43 per craft for a permit valid for one month.
 - 3. Fees for berths at wharves, jetties, and breastworks—
 - (a) \$13.50 per berth per day:
 - (b) \$42 per berth per week:
 - (c) One-eighth of the appropriate annual fee, per craft for a permit valid for one month.

"SURVEY FEE RATE (INCLUDING GST) \$68 per hour."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1989, amend the Lake Taupo Regulations 1976 so as to have wardens appointed by the Regional Manager of the Rotorua Office of the Department of Internal Affairs (rather than the Secretary for Local Government), increase the fees payable in respect of facilities provided by the Harbourmaster, and prescribe an hourly rate payable in respect of surveys done for the purposes of the principal regulations.
