

THE LAKE TAUPO REGULATIONS 1976, AMENDMENT NO. 9

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Harbours Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Lake Taupo Regulations 1976, Amendment No. 9, and shall be read together with and deemed part of the Lake Taupo Regulations 1976* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.

- 2. Private moorings—Regulation 9 (4) of the principal regulations (as amended by regulation 3 of the Lake Taupo Regulations 1976, Amendment No. 8) is hereby amended by omitting the words "an application fee of \$57", and substituting the words "the application fee specified in clause 1 of the Fourth Schedule to these regulations".
- **3.** Use of wharves and facilities—Regulation 10 of the principal regulations is hereby amended by revoking subclause (3), and substituting the following subclauses:
- "(3) Every application for an annual permit shall be accompanied by the application fee specified in clause 2 of the Fourth Schedule to these regulations; and, if a permit is granted in respect of the application, the holder shall then and in every subsequent year in which the holder holds such a permit pay to the Harbourmaster the appropriate annual fee specified in the First Schedule to these regulations.

"(3A) Every application for a permit to be issued for a period of less than a year shall be accompanied by the appropriate fee specified in the Second

Schedule to these regulations.'

4. Amount of goods and services tax included—The principal regulations are hereby amended by inserting, after regulation 28A (as inserted by regulation 7 of the Lake Taupo Regulations 1976, Amendment No. 2), the following regulation:

"28B. The fees specified in the Schedules to these regulations are inclusive of goods and services tax under the Goods and Services Tax Act

1985."

- **5. New Schedules of fees substituted**—The principal regulations are hereby amended by revoking the Schedules (as substituted by regulation 5 of the Lake Taupo Regulations 1976, Amendment No. 8), and substituting the new Schedules set out in the Schedule to these regulations.
- **6. Revocations**—Regulations 3, 5, and 6 of the Lake Taupo Regulations 1976, Amendment No. 8 are hereby consequentially revoked.

NEW SCHEDULES SUBSTITUTED IN PRINCIPAL REGULATIONS

"FIRST SCHEDULE

"ANNUAL FEES

- 1. Fees for mooring sites—Either \$131 or an amount calculated at a rate of \$12 per metre of the length of the craft to be moored at the site, calculated on the basis of the overall length of the craft including all permanent extrusions, whichever is the greater.
- 2. Fee for permit to use launching ramps and similar facilities controlled by the Secretary—\$51 per craft.
 - 3. Fees for berths and wharves, jetties, and breastworks—
 - (a) Parallel berths—\$71 per metre of berth:
 - (b) Bow-in berth (not at jetty) berths—\$100 per metre of berth:
 - (c) Bow-in (at jetty) berths—\$280 per metre of berth.

4. Fees for licences for commercial vessels—

- (a) Vessels surveyed to carry fewer than 7 passengers—\$206:
- (b) Vessels surveyed to carry more than 6 and fewer than 13 passengers—\$257:
- (c) Vessels surveyed to carry more than 12 and fewer than 25 passengers—\$309:
- (d) Vessels surveyed to carry more than 24 and fewer than 37 passengers—\$359:
- (e) Vessels surveyed to carry more than 36 and fewer than 61 passengers—\$412:
- (f) Vessels surveyed to carry more than 60 passengers—\$412, plus \$5 per passenger in excess of 60.

5. Fees for licences for rental vessels—

- (a) Power-driven vessels—\$51:
- (b) Other vessels-
 - (i) Vessels surveyed to carry only 1 passenger—\$16:
 - (ii) Vessels surveyed to carry only 1 or 2 passengers—\$22:
 - (iii) Vessels surveyed to carry more than 2 and fewer than 8 passengers—\$27:
 - (iv) Vessels surveyed to carry more than 7 and fewer than 12 passengers—\$79:
 - (v) Vessels surveyed to carry more than 11 passengers—\$104.

"FEES FOR PERIODS OF LESS THAN ONE YEAR

1. Fees for permit to use launching ramps and similar facilities controlled by Secretary—

- (a) \$4 per craft for a permit valid for one day:
- (b) \$9 per craft for a permit valid for one week:
- (c) \$19 per craft for a permit valid for one month.

2. Fees for berths at wharves, jetties, and breastworks—

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the *Gazette*, reduce most of the fees payable in respect of facilities and services provided by the Harbourmaster. The survey fee is increased from \$68 per hour to \$71 per hour and a new application fee for annual berthing permits is prescribed. The fees are inclusive of goods and services tax.
