**R U L E S**

**1. Title and commencement**—(1) These rules may be cited as the Land Valuation Court Rules 1953, Amendment No. 4, and shall be read together with and deemed part of the Land Valuation Court Rules 1953\* (hereinafter referred to as the principal rules).

(2) These rules shall come into force on the 1st day of December 1967.

**2. Scale of fees**—The principal rules are hereby amended by revoking the Second Schedule, and substituting the Second Schedule set out in the Schedule to these rules.
