## THE LAKE WAIKAREMOANA EXPERIMENTAL WATERS REGULATIONS 1970

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title, commencement, and expiration—(1) These regulations may be cited as the Lake Waikaremoana Experimental Waters Regulations 1970, and shall be read together with and deemed part of the Rotorua Trout Fishing Regulations 1966\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 3rd day of October 1970 and shall expire with the 30th day of June 1971.

2. Lake Waikaremoana and certain streams declared fisheries experimental waters—Lake Waikaremoana and all streams flowing into Lake Waikaremoana (but excluding that part of the Hopuruahine River from its source to the main Rotorua-Wairoa highway bridge) (hereinafter called the said waters) are hereby declared to be fisheries experimental waters.

3. Principal regulations to apply as varied—The principal regulations shall continue to apply to the said waters except as varied by these regulations.

4. No fishing without permit—(1) Notwithstanding anything in the principal regulations or in any licence issued thereunder, no person shall fish for trout in the said waters unless he is the holder of a written permit issued for that purpose by the Secretary for Internal Affairs or his appointee, and subject to such conditions as may be specified in the permit.

\*S.R. 1966/109 Amendment No. 1: S.R. 1969/107 (2) Every issuing officer authorised pursuant to regulation 5 of the principal regulations to issue licences is hereby authorised to issue permits under these regulations.

5. Permits to be issued to licence holders—(1) No permit shall be issued to any person who is not the holder of a current licence issued under the principal regulations.

(2) Upon request by the holder of a current licence issued under the principal regulations made to an issuing officer at any time when licences are being offered for sale, the issuing officer shall issue to him a permit under these regulations.

6. No fee for permit—No fee shall be charged for any permit issued under these regulations.

**7. Duration of permit**—Every permit issued under these regulations shall continue in force during the currency of the licence held at the time of issue of the permit by the person to whom it is issued.

8. Permit to be produced—The holder of a permit shall produce it to any officer of the Department of Internal Affairs or any ranger on demand.

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations declare Lake Waikaremoana and streams flowing into the lake to be fisheries experimental waters under the provisions of section 91 (A) of the Fisheries Act 1908, which provides that a water may be set aside as fisheries experimental waters. These regulations prohibit fishing in those waters unless the angler holds, in addition to his ordinary licence to fish, a permit issued by the Department of Internal Affairs and complies with all conditions set out in the permit.
