PURSUANT to section 65 of the Mutual Assistance in Criminal Matters Act 1992, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Mutual Assistance in Criminal Matters (Prescribed Foreign Country) (United Kingdom) Regulations 1993.

(2) These regulations shall come into force on the day after the date of

their notification in the Gazette.

2. Application of Part III of Mutual Assistance in Criminal Matters Act 1992 to United Kingdom—(1) Subject to subclause (2) of this regulation, it is hereby declared that Part III of the Mutual Assistance in Criminal Matters Act 1992 applies to the United Kingdom.

(2) No request for assistance pursuant to Part III of the Mutual Assistance in Criminal Matters Act 1992 may be made by the United

Kingdom pursuant to any of the following provisions of that Part of that

- (a) Section 38 (which relates to assistance in arranging the attendance, in a foreign country, of prisoners and certain other persons):
- (b) Section 54 (which relates to assistance with the enforcement of a foreign forfeiture order or a foreign pecuniary penalty order):
- (c) Section 55 (which relates to assistance with the enforcement of a foreign restraining order):
- (d) Section 59 (which relates to a request for the obtaining of the issue of a search warrant in respect of tainted property):
- (e) Section 60 (which relates to a request for the obtaining of the issue of a restraining order):
- (f) Section 61 (which relates to a request for the obtaining of the issue of a production order):
- (g) Section 62 (which relates to a request for the obtaining of the issue of a monitoring order).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations declare that, with certain exceptions, Part III of the Mutual Assistance in Criminal Matters Act 1992 applies to the United Kingdom. This means that, subject to those exceptions, requests may be made by the United Kingdom to New Zealand for assistance pursuant to that Part of that Act.
