# THE MUNICIPAL CORPORATIONS REGULATIONS 1956, AMENDMENT NO. 2

## COBHAM, Governor-General

#### ORDER IN COUNCIL

At the Government Buildings at Wellington this 9th day of April 1962

### Present:

THE RIGHT HON. KEITH HOLYOAKE PRESIDING IN COUNCIL

Pursuant to the Municipal Corporations Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the Municipal Corporations Regulations 1956, Amendment No. 2, and shall be read together with and deemed part of the Municipal Corporations Regulations 1956\* (hereinafter referred to as the principal regulations).
- 2. Regulation 3 of the principal regulations is hereby amended by omitting the words "31st day of July", and substituting the words "30th day of June".
- 3. Regulation 8 of the principal regulations is hereby amended by omitting the word "August" wherever it occurs, and substituting in each case the word "July".
- 4. Regulation 9 of the principal regulations is hereby amended by omitting the word "August", and substituting the word "July".
- 5. Regulation 10 of the principal regulations is hereby amended by omitting the word "August", and substituting the word "July".
  - 6. Regulation 16 of the principal regulations is hereby amended—
  - (a) By omitting the word "October", and substituting the word "September":
  - (b) By omitting the words "30th day of September", and substituting the words "31st day of August".

7. The principal regulations are hereby further amended by inserting,

after regulation 32, the following regulation:

"32A. The Council may, by resolution, determine that shillings and pence shall be excluded from the accounts, balance sheet, and statements required by regulation 32 hereof to be prepared, and in that case the Treasurer shall prepare those accounts, balance sheet, and statements accordingly."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulations 2 to 6 of these regulations make such changes in Part I of the principal regulations as are necessary following the alteration by the Local Elections and Polls Amendment Act 1961 in the date for the holding of the general elections of City, Borough, and Town Councils from the third Saturday in November to the second Saturday in October.

The dates before which certain formalities in connection with the enrolment

of electors are to be complied with are advanced by a month in each case.

Regulation 7 permits the annual accounts of City, Borough, and Town Councils to be prepared, if the Council so decides, on a whole-pounds basis, that is, excluding shillings and pence.
