THE MUNICIPAL CORPORATIONS REGULATIONS 1956, AMENDMENT NO. 6

PURSUANT to the Municipal Corporations Act 1954, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Municipal Corporations Regulations 1956, Amendment No. 6, and shall be read together with and deemed part of the Municipal Corporations Regulations 1956* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette:

Provided that the principal regulations shall continue to apply, as if these regulations had not been made, for the purpose of any election to fill an extraordinary vacancy on the Council or in the office of Mayor and of any poll if that election or poll is held before the 12th day of October 1974.

- 2. Enrolment of electors—Regulation 3 of the principal regulations is hereby amended—
 - (a) By omitting the words "freehold qualification":
 - (b) By omitting the word "freehold" where it secondly occurs.

- 3. Forms—(1) The First Schedule to the principal regulations is hereby amended by revoking form 2, and substituting the form 2 set out in the Schedule to these regulations.
- (2) The Municipal Corporations Regulations 1956, Amendment No. 4, is hereby revoked.

Note: By section 29 of the Municipal Corporations Act 1954 every person who wilfully makes a false claim to have his name entered on the district electors list is liable to a fine not exceeding \$10.

(Note-If the Council so desires, a separate form of claim for enrolment may be used in respect of each qualification).

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations make such amendments to the principal regulations as are necessary by reason of the provisions of the Municipal Corporations Amendment Act 1974 reducing the voting age to 18 years and abolishing the freehold qualification.

Regulation 2 amends regulation 3 of the principal regulations, relating to the enrolment of electors, by omitting references to the freehold qualification.

Regulation 3 substitutes new forms of District Electors List and of Claim for

Enrolment with consequential changes.
