**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 13th day of March 1978

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the Municipal Corporations Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title**—These regulations may be cited as the Municipal Corporations Regulations 1956, Amendment No. 8, and shall be read together with and deemed part of the Municipal Corporations Regulations 1956\* (hereinafter referred to as the principal regulations).

**2. Fee for copy of roll**—(1) Regulation 17 (2) of the principal regulations (as amended by regulation 2 of the Municipal Corporations Regulations 1956, Amendment No. 5) is hereby further amended by omitting the words “not exceeding \$1”, and substituting the words “not exceeding \$2”.

(2) The Municipal Corporations Regulations 1956, Amendment No. 5, is hereby revoked.

**3. Form of district electors list**—The First Schedule to the principal regulations is hereby amended by revoking Form 1, and substituting the Form 1 set out in the Schedule to these regulations.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

Regulation 2 increases from \$1 to \$2 the maximum fee that may be charged by a Council for a copy of the district electors roll and all its supplements.

Regulation 3 substitutes a new form of the District Electors List in the principal regulations. The new form omits the reference to the elector's occupation, and provides for his residential address only to be shown in all cases instead of showing, in the case of an elector with a rating qualification, the address of his qualifying property.
