**THE MATAURA LICENSING TRUST ORDER 1955**

**ORDER IN COUNCIL**

At the Government House at Wellington this 26th day of October 1955

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Licensing Trusts Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

---

**ORDER**

1. This order may be cited as the Matura Licensing Trust Order 1955.
2. The area described in the First Schedule hereto is hereby declared to be a licensing Trust district, to be called the Matura Licensing Trust district (in this order referred to as the Trust district), for the purposes of Part I of the Licensing Trusts Act 1949.
3. There is hereby constituted for the Trust district a Licensing Trust to be called the Matura Licensing Trust (in this order referred to as the Trust).
4. For the purposes of elections of members of the Trust, the Trust district is hereby divided into seven wards, being the wards described in the Second Schedule hereto.
5. The Trust shall consist of nine elective members, of whom three shall be elected for Ward 2 described in the Second Schedule hereto and one shall be elected for each of the other wards described in that Schedule.
6. The terms of office of five of the members of the Trust to be elected at the first election of members shall expire, in accordance with section 5 of the Licensing Trusts Act 1949, on the day appointed for the second election of members pursuant to that Act.
7. At any meeting of the Trust four members shall form a quorum.

## SCHEDULES

## FIRST SCHEDULE

## MATAURA LICENSING TRUST DISTRICT

ALL that area bounded by a line commencing at the south-eastern corner of Section 5, Block XI, Crookston Survey District; thence southerly along the eastern boundaries of Blocks XI and X, Crookston Survey District, and the production of the last-mentioned boundary to the Rangleburn Stream; thence down that stream to and up the Pomahaka River to and up the Waipahi River to its intersection with the Edievale Branch Railway; thence westerly along that railway to and south-easterly along the Main Trunk Railway to a point in line with the northern boundary of Section 6, Block VI, Waipahi Survey District; thence to and along the northern and western boundaries of that section to and along the road intersecting Allotments 3, 5, 2, and 6, Waipahi Estate, to the north-western corner of Section 14, Block XVI, Waipahi Survey District; thence to and up the Waipahi River to and along the eastern boundaries of Sections 24 and 23, Block XII, Waipahi Survey District; thence along the road forming the generally eastern boundaries of Sections 1, 4, 6, 7, 13, and 12, Block II, Slopdown Survey District, to and along the northern, eastern, and south-eastern boundaries of Section 2, Block VI, Slopdown Survey District; thence along the eastern and south-eastern boundaries of Run 251 to the south-western boundary of Section 5, Block VII, Slopdown Survey District; thence along that boundary and its production to the Mokoreta River; thence up that river to the south-western boundary of Run 258 and along that boundary to its intersection with a straight line between the source of the Waipahi River and Catlins Cone, Block II, Rimu Survey District; thence along that line to Catlins Cone; thence along the summit of the watershed over Chimney to Bleak Hill in Block VI, Mokoreta Survey District; thence south-easterly along a straight line to the confluence of Mary Burn and the Tahakopa River and down the Tahakopa River to its mouth; thence westerly generally along the sea-coast to the outlet of Waituna Lagoon; thence along the generally western, south-western and northern shores of Waituna Lagoon to and along the western boundaries of Sections 40, 39, 38, 37, and 36, the western and northern boundaries of Section 35, the western boundaries of Sections 19, 16, 13, 10, 7, 4, and 1, all of Block V, Oteramika Hundred, the western boundaries of Sections 63, 51, 50, 48, 46, 44, 42, 77, 40, 39, and 73, the north-western boundaries of Sections 38, 18, 19, 17, and 16, all of Block III, Oteramika Hundred, to and along the road forming the north-western boundary of Section 10, Block III, to and along the road forming the western boundaries of Sections 64, 111, 63, 62, 41, 40, 39, and 38, Block I, Oteramika Hundred, to and along the road forming the south-western boundaries of Sections 33, 32, 106, 31, and 17 and the south-western and north-western boundaries of Section 66, all of Block I, Oteramika Hundred, to and along the road intersecting Woodlands Estate from the south-eastern corner of Original Section 51, Block VI, Oteramika Hundred, to the north-western corner of original Section 4 of the said Block VI, to and along the southern and eastern boundaries of Lot 116, L.T. Plan 85, to and along the Main Trunk Railway, to and along the eastern boundary of Mabel Hundred, and the eastern boundary of Forest Hill Hundred, to its north-eastern corner; thence by the southern and western boundaries

of Section 253, Block 64, Hokonui Survey District, and the western and northern boundaries of Section 267, Block 47, Hokonui Survey District, to the Otamita Stream; thence by that stream to and along the Mataura River to the Okapua Creek; thence by that creek to its intersection with the road forming the south-western boundary of Section 15, Block VI, Chatton Survey District; thence by the road forming the south-western boundary of the said Section 15 and the southern boundaries of Sections 16, 25, 17, 24, and 26, again by the southern boundary of the said Section 17 and the southern boundaries of R. 214 and Section 18, all of the said Block VI, to and along the road forming the southern boundaries of Sections 12, 13, and 14, Block V, to and along the road forming the southern boundaries of Sections 6, 5, 4, 3, and 1, Block III, to the Waikaka Stream; thence by that stream to and along the road forming the southern boundaries of Sections 4, 3, and 2, Block VIII, all of the said Chatton Survey District, to and along the eastern boundary of the aforesaid Chatton Survey District and the production of that boundary to the middle of the Leithen Burn; thence down the middle of Leithen Burn to and down the middle of the Pomahaka River to a point due south of the easternmost corner of original Section 4, Block II, Greenvale Survey District; thence due north to that corner; thence northerly generally to and along the middle of Paradise Road, Stable Road, Kelso Road, and Moncurs Road to a point in line with the northern boundary of Lot 1 on Deposited Plan No. 3184; thence easterly to and along that boundary, the northern boundaries of Sections 11, 9, and 20, Block IV, Greenvale Survey District, the northern boundary of Section 37, Block III, Crookston Survey District, the middle of the road forming the northern boundary of Section 32 and the northern and north-eastern boundaries of Section 31, Block III, aforesaid, to and along the north-eastern boundaries of Sections 12 and 1, Block III, aforesaid, to Trig. Station T; thence along the southern boundaries of Sections 1, 2, and 3 and the south-eastern boundaries of Section 3 aforesaid, and Section 5, all of Block XI, Crookston Survey District, to the point of commencement.

All that area comprising—

*Ward 6 (one member)*

All that area comprising—

- (a) The Town District of Wyndham:
- (b) That part of the Toetoes Riding of the County of Southland situated to the north of a line commencing at the intersection of the northern boundary of the Toetoes Survey District with the left bank of the Mataura River; thence easterly along the northern boundary of that survey district to and along the northern boundaries of Blocks IX and X, Mokoreta Survey District, along the southern boundary of Section 2, Block VIII, Mokoreta Survey District, and along the production of the last-mentioned boundary to the middle of Caddon Road; thence along the middle of Caddon Road to and along the middle of the track to MacLennans to its intersection with the eastern boundary of the said Toetoes Riding.

*Ward 7 (one member)*

All that area comprising—

- (a) That part of the Toetoes Riding of the County of Southland situated to the south of a line commencing at the intersection of the northern boundary of the Toetoes Survey District with the left bank of the Mataura River; thence easterly along the northern boundary of that survey district to and along the northern boundaries of Blocks IX and X, Mokoreta Survey District, along the southern boundary of Section 2, Block VIII, Mokoreta Survey District, and along the production of the last-mentioned boundary to the middle of Caddon Road; thence along the middle of Caddon Road to and along the middle of the track to MacLennans to its intersection with the eastern boundary of the said Toetoes Riding:
- (b) That part of the MacLennan Riding of the County of Clutha within the Mataura Licensing Trust District.
