THE MONEY ORDER REGULATIONS 1949,  
AMENDMENT NO. 4

ORDER IN COUNCIL

At the Government Buildings at Wellington this 28th day of March 1967

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Money Order Regulations 1949, Amendment No. 4, and shall be read together with and deemed part of the Money Order Regulations 1949\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1967.

2. (1) The principal regulations are hereby amended by revoking regulation 24 (as amended by regulation 2 of the Money Order Regulations 1949, Amendment No. 3) and substituting the following regulation:

“24. The commission on a money order payable in New Zealand shall be 1s. 0d. for any amount not exceeding ten pounds and an additional 6d. for each additional ten pounds or fraction thereof. For a telegraph order there shall be payable in addition a telegraph fee of 3s. 0d. if sent at ordinary rates and 5s. 0d. if sent urgent, plus 2½d. for each word included in any private message added to the official telegram. The remitter of a telegraph order must write the private message in the space provided on the requisition form and may prepay the cost of a telegraphic reply:

“Provided that money orders payable within or beyond New Zealand may be issued free of charge at the discretion of the Postmaster-General.”

(2) The Money Order Regulations 1949, Amendment No. 3, are hereby revoked.

3. The principal regulations are hereby further amended by revoking regulation 30, and substituting the following regulation:

"30. The commission on money orders forwarded by post for payment in the Australian States, Fiji, Norfolk Island, Tonga, and countries specified by the Postmaster-General from time to time as being countries to which money orders are forwarded through the Australian Postal Administration shall be 6d. for each two pounds or fraction thereof with a minimum charge of 1s. 6d."

4. Regulation 31 of the principal regulations is hereby amended by omitting the words "3d. for every £1 or fraction thereof", and substituting the words "6d. for each one pound or fraction thereof, with a minimum charge of 1s. 6d."

5. Regulation 51 of the principal regulations is hereby amended by omitting the words "3d.", and substituting the words "1s. 0d."

6. Regulation 56 of the principal regulations is hereby amended by omitting the words "6d.", and substituting the words "1s. 0d."

7. Regulation 62 of the principal regulations is hereby amended by omitting the words "of 1s. 6d. for the first thirty minutes or fraction thereof of the time involved in the search, and 9d. for each additional fifteen minutes or fraction thereof", and substituting "of 8s. 0d. for each thirty minutes or fraction thereof of the time involved in the search."

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations increase from 1 April 1967:

- (1) Commission charges for money orders.
- (2) Rates of charges for telegraph money orders.
- (3) (a) Charge for advice of payment of a money order.  
(b) Charge for issue of a duplicate money order.  
(c) Charge for a search of records to obtain information about the payment of a money order.
