**THE MILK PRODUCER AND OTHER PRICES NOTICE 1968,  
AMENDMENT NO. 10**

PURSUANT to the Milk Act 1967, the Minister of Agriculture hereby gives the following notice.

—

NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Milk Producer and Other Prices Notice 1968, Amendment No. 10, and shall be read together with and deemed part of the Milk Producer and Other Prices Notice 1968\* (hereinafter referred to as the principal notice).

(2) Clause 2 of this notice shall be deemed to have come into force on the 1st day of September 1970, and clause 3 of this notice shall be deemed to have come into force on the 1st day of September 1971.

**2. First Schedule substituted**—(1) The principal notice is hereby amended by revoking the First Schedule (as substituted by clause 2 of the Milk Producer and Other Prices Notice 1968, Amendment No. 9), and substituting the First Schedule set out in the Schedule hereto.

(2) The Milk Producer and Other Prices Notice 1968, Amendment No. 9 is hereby revoked.

**3. Second Schedule amended**—The Second Schedule to the principal notice is hereby amended by omitting paragraphs (a) to (c) of item 2, and substituting the following paragraphs:

“(a) Up to and including 2,000 gallons per day	0.61
“(b) More than 2,000 gallons and up to and including 7,500 gallons per day .....	0.43
“(c) Over 7,500 gallons per day .....	0.30”
