### THE MILK PRODUCER AND OTHER PRICES NOTICE 1968, AMENDMENT NO. 15

PURSUANT to the Milk Act 1967, the Minister of Agriculture and Fisheries hereby gives the following notice.

### NOTICE

1. Title and commencement—(1) This notice may be cited as the Milk Producer and Other Prices Notice 1968, Amendment No. 15, and shall be read together with and deemed part of the Milk Producer and Other Prices Notice 1968\* (hereinafter referred to as the principal notice).

(2) Except as provided in clause 2 of this notice, this notice shall

come into force on the 1st day of March 1974.

2. First Schedule substituted—(1) The principal notice is hereby amended by revoking the First Schedule (as substituted by clause 2 of the Milk Producer and Other Prices Notice 1968, Amendment No. 14), and substituting the First Schedule set out in the First Schedule to these regulations.

(2) The Milk Producer and Other Prices Notice 1968, Amendment

No. 14 is hereby revoked.

- (3) This clause shall be deemed to have come into force on the 1st day of September 1972.

#### EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice increases the town milk producer price from 23.56 to 25.88 cents per gallon for the period commencing with 1 September 1973 and ending with 31 January 1974; from 29.21 to 32.10 cents per gallon for the period commencing with 1 February 1974 and ending with 28 February 1974; from 6.426 to 7.061 cents per litre for the period commencing with 1 March 1974 and ending with 30 April 1974; and from 8.295 to 9.111 cents per litre for the period commencing with 1 May 1974 and ending with 31 August 1974.

A further effect of this notice is to notify allowances and margins for specified services payable by the New Zealand Milk Board to approved associations pursuant to section 25 (4) of the Milk Act 1967. The notice amends the Milk Producer and Other Prices Notice 1968 by expressing margins or allowances per litre instead of per gallon and by revoking provisions relating to margins and allowances on can collection services. Except for clause 2 of the notice (which is deemed to have come into force on 1 September 1972) the notice comes into force on 1 March 1974.
