THE RIGHT HON. M. J. SAVAGE PRESIDING IN COUNCIL.

PURSUANT to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby, on the recommendation of the Minister of Industries and Commerce, make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Motor-spirits Prices (Otago and Southland) Regulations 1938, Amendment No. 1.
2. These regulations shall come into force on the day following notification in the *Gazette* of the making thereof.*
3. These regulations shall be read together with and form part of the Motor-spirits Prices (Otago and Southland) Regulations 1938† (hereinafter called the principal regulations).
4. The Second Schedule to the principal regulations, as affected by the Motor-spirits Prices General Regulations 1938, Amendment No. 1,‡ is revoked, and the following substituted.
