**THE MOTOR-SPIRITS PRICES (HAWKE'S BAY - WAIRARAPA)
REGULATIONS 1937, AMENDMENT NO. 3.**

ORDER IN COUNCIL.

At the Government House at Wellington, this 24th day of
October, 1940.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 3 of the Motor-spirits (Regulation of
Prices) Act, 1933, His Excellency the Governor-General, acting
by and with the advice and consent of the Executive Council
and on the recommendation of the Minister of Industries and
Commerce, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Motor-spirits
Prices (Hawke's Bay - Wairarapa) Regulations 1937, Amend-
ment No. 3.
2. These regulations shall be read together with and form
part of the Motor-spirits Prices (Hawke's Bay - Wairarapa)
Regulations 1937 (hereinafter called the principal regulations).
3. These regulations shall come into force on the day
following notification in the *Gazette* of the making thereof.

4. The principal regulations are amended by revoking the Second Schedule thereto as enacted by the Motor-spirits Prices (Hawke's Bay - Wairarapa) Regulations 1937, Amendment No. 2, and substituting the following:—
