THE MOTOR-SPIRITS PRICES DISTRICT REGULATIONS 1941.

ORDER IN COUNCIL.

At the Government House at Wellington, this 7th day of
March, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS it is expedient to revoke and consolidate certain enactments heretofore in force under the Motor-spirits (Regulation of Prices) Act, 1933, and to alter the prices of motor-spirits heretofore fixed :

Now, therefore, pursuant to section 3 of the said Act, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Motor-spirits Prices District Regulations 1941.

2. These regulations shall come into force on the 10th day of March, 1941.

3. The regulations referred to in the First Schedule hereto are revoked to the extent specified in the said First Schedule, and if not otherwise therein specified, then wholly revoked.

4. All prices of motor-spirits fixed by the regulations referred to in the Second, Third, Fourth, Fifth, and Sixth Schedules hereto respectively shall, on and after the date of coming into force of these regulations, be respectively 7½d., 6½d., 6d., 5½d., and 2½d. more per imperial gallon than the respective prices prescribed in the regulations so referred to as modified by the amendments referred to in the said Second to Sixth Schedules (inclusive).

5. All prices of motor-spirits fixed by the regulations referred to in the Seventh and Eighth Schedules hereto respectively shall, on and after the date of coming into force of these regulations, be respectively $\frac{3}{4}$ d. and 1d. less per imperial gallon than the respective prices prescribed in the regulations so referred to as modified by the amendments referred to in the said Seventh and Eighth Schedules.

6. Wherever in any of the regulations referred to in the Second to Eighth Schedules hereto (inclusive) the term "bulk consumer" is defined and the definition contains a reference to the number "4,800," the number "4,800" in such definition is revoked and the number "3,500" substituted therefor.

7. Wherever in the respective regulations cited in the Third Column of the Ninth Schedule hereto the figures "400" or "4,800" occur, these figures are revoked and the figures "292" or "3,500" respectively substituted therefor.

8. The provisions of Regulation 13 and paragraph (c) of Regulation 15 of the Motor-spirits Prices General Regulations 1940* shall apply to all the regulations referred to in the Second to Eighth Schedules hereto (inclusive) in which such provisions are not already included as fully as if they had been set out at length therein.

9. Nothing herein contained shall prejudice the continuing effect of the Motor-spirits Prices General Regulations 1940 as part of any regulations of which they are declared to form part.
