THE MOTOR-SPIRITS PRICES DISTRICT REGULATIONS 1941, AMENDMENT NO. 2.

At the Government House at Wellington, this 24th day of September, 1941.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Motor-spirits Prices District Regulations 1941, Amendment No. 2.
- 2. These regulations shall be read with and form part of the Motor-spirits Prices District Regulations 1941* (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the date following notification in the Gazette of the making thereof.†
- 4. The regulations to be cited as the Motor-spirits Prices District Regulations 1941, Amendment No. 1, are hereby revoked.
- 5. Regulation 4 of the principal regulations as heretofore amended is further amended by revoking the words and expressions " $8\frac{1}{2}$ d., $7\frac{1}{2}$ d., 7d., $6\frac{1}{2}$ d., and $3\frac{1}{2}$ d. more", and substituting the following words and expressions: " $9\frac{1}{2}$ d., $8\frac{1}{2}$ d., 8d., $7\frac{1}{2}$ d., and $4\frac{1}{2}$ d. more".
- 6. Regulation 5 of the principal regulations as heretofore amended is further amended by revoking the words and expressions "½d. per imperial gallon more than and the same as", and substituting the following words and expressions: "½d. and 1d. more per imperial gallon than".
