PURSUANT to section 15 of the Medical Practitioners Act 1968, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Medical Practitioners (Higher Overseas Qualifications) Order 1973.

(2) This order shall come into force on the day after the date of its notification in the *Gazette*.

2. Higher overseas qualifications for conditional registration—The Second Schedule to the Medical Practitioners Act 1968 (as added by section 5 (3) of the Medical Practitioners Amendment Act 1970) is hereby amended—

(a) By omitting, from items 7 and 8 respectively, the word "Surgical", and by omitting items 11 and 17:

(b) By adding the following items:

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

The Second Schedule to the Medical Practitioners Act 1968 specifies post-graduate qualifications overseas that are recognised in New Zealand for the purpose of conditional registration of medical practitioners. Clause 2 (a) of this order amends the Second Schedule to refer generally to Fellowships of the Royal Colleges of Physicians and Surgeons of Glasgow and Canada respectively. The amendment follows the present practice of those bodies, and does not in any way prejudice practitioners or prospective applicants for conditional registration. for conditional registration.

Clause 2 (b) of this order adds 30 more qualifications to the Second Schedule.
