## ORDER IN COUNCIL

#### HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to section 39 of the Medical Practitioners Act 1968, His Excellency the Governor-General, acting on the advice of the Minister of Health given after consultation by the Minister with the Medical Council of New Zealand, and by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Medical Practitioners (Registration of Specialists) Regulations 1971, Amendment No. 7, and shall be read together with and deemed part of the Medical Practitioners (Registration of Specialists) Regulations 1971\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

(2) The First Schedule to the principal regulations (as so substituted) is hereby amended by omitting from the third and fifth columns relating to obstetrics and gynaecology (as substituted by regulation 3 (2) of the Medical Practitioners (Registration of Specialists) Regulations 1971, Amendment No. 6), the expression "New Zealand College of Obstetricians and Gynaecologists", and substituting in each case the expression "Royal New Zealand College of Obstetricians and Gynaecologists".

(3) The First Schedule to the principal regulations (as so substituted) is hereby further amended by omitting from the fourth column in relation to radiotherapy the item "(b) Membership (Therapy)".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the list of registrable specialties and qualifications under the Medical Practitioners Act 1968. They reflect the following changes:

(a) The body formerly known as the New Zealand College of Obstetricians and Gynaecologists is now known as the Royal New Zealand College of Obstetricians and Gynaecologists:

(b) The Royal Australasian College of Radiologists no longer recognises the status of members. Existing members will become fellows.
