HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Motor-spirits Prices Regulations 1942, Amendment No. 6.
- 2. These regulations shall be read together with and form part of the Motor-spirits Prices Regulations 1942* (herein called the principal regulations).
- 3. These regulations shall come into force on the day following notification in the Gazette of the making thereof.
 - 4. The Third Schedule to the principal regulations is amended—
- (a) By deleting the following words in the description of Sales Area 41: "Trig. Station J 2 at the southernmost corner of Section 5, Block I, Heretaunga Survey District", and substituting therefor the following words: "the northernmost corner of Section 2s, Rissington Settlement, situated in Block XIII, Puketapu Survey District", and by deleting the word "Rissington" from the list of place names appended to the description of Sales Area 41.
- (b) By adding the word "Rissington" to the list of place-names appended to the description of Sales Area 42.
 - (c) By deleting the following words—
 - "Sales Area 65 (Set of Differentials applicable: No. 14)
 - "The Borough of Foxton.
- "Foxton."

- (d) By deleting the whole of the heading and description of Sales Area 66 and the place-names appended thereto, and substituting therefor the following:—
 - "Sales Area 66 (Set of Differentials applicable: No. 12)
- "All that area in the Wellington Land District bounded by a line commencing at a point on the Tokomaru Stream in line with the north-western boundary of Section 21, Block V, Arawaru Survey District; thence down that stream to the North Island Main Trunk Railway; thence along a right line passing through Omarupapaku Trig. Station to the sea-coast; thence southerly along the sea-coast to a point in line with the south-western boundary of Section 61, Block II, Paekakariki Survey District; thence easterly to and along that boundary, across a public road and the North Island Main Trunk Railway, to and along the south-western boundary of Whareroa No. 4 Block, to the southernmost corner of that Block; thence along a right line to the Tokomaru Stream at the north-western boundary of Section 21, Block V, Arawaru Survey District, the place of commencement.
