PURSUANT to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

#### REGULATIONS

1. These regulations may be cited as the Motor-spirits Prices Regulations 1942, Amendment No. 7.

2. These regulations shall be read together with and form part of the Motor-spirits Prices Regulations 1942\* (hereinafter called the principal regulations).

3. These regulations shall come into force on the day following

notification in the Gazette of the making thereof.
