### THE MOTOR-SPIRITS PRICES REGULATIONS 1942, AMENDMENT NO. 9

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 3 of the Motor-spirits (Regulation of Prices) Act, 1933, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the recommendation of the Minister of Industries and Commerce, doth hereby make the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the Motor-spirits Prices Regulations 1942, Amendment No. 9.
- 2. These regulations shall be read together with and form part of the Motor-spirits Prices Regulations 1942\* (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the day following notification in the *Gazette* of the making thereof.
- 4. The Second Schedule (Table of Differentials) of the principal regulations is amended in respect of Set of Differentials No. 15—
  - (a) By deleting from the column headed "Scale D" the figures " $1\frac{1}{2}$ ", and substituting therefor the figure "1".
  - (b) By deleting from the column headed "Scale E" the figures "1\frac{1}{2}", and substituting therefor the figure "1".
  - 5. The Third Schedule of the principal regulations is amended—
  - (a) In respect of the differentials applicable to Sales Area 75, by revoking the words and figures (as heretofore substituted) "Set of Differentials applicable: No. 11", and substituting therefor the following words and figures: "Set of Differentials applicable: No. 15":

- (b) In respect of the differentials applicable to Sales Area 76, by revoking the words and figures (as heretofore substituted) "Set of Differentials applicable: No. 21", and substituting therefor the following words and figures: "Set of Differentials applicable: No. 14":
- (c) In respect of the differentials applicable to Sales Area 78, by revoking the words and figures "Set of Differentials applicable: No. 27", and substituting therefor the following words and figures: "Set of Differentials applicable: No. 23":
- (d) By deleting the following words in the description of Sales Area 81: "thence again south-westerly along a right line to the southernmost corner of the Borough of Hokitika; thence to and along the middle of the Hokitika River to its mouth", and substituting therefor the following words: "thence again south-westerly along a right line to a point 40 chains due south of the Kanieri Post-office; thence due west along a right line to the middle of the Hokitika River; thence north-westerly down the middle of the river to its mouth":
- (e) By inserting the place-names "Ho Ho" and "Kaniere" next following the place-names "Greenstone" and "Kamaka" respectively in the list appended to the description of Sales Area 81:
- (f) By deleting the place-names "Ho Ho" and "Kaniere." from the list appended to the description of Sales Area 84.
- 6. Upon the coming into force of these regulations all references in the principal regulations to Sales Area 81 and to Sales Area 84 shall be deemed to be references to those Areas as respectively altered by these regulations.
