



THE MEDICAL PRACTITIONERS (FEES) REGULATIONS 1987

ORDER IN COUNCIL

At Wellington this 16th day of March 1987

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 75 (c) of the Medical Practitioners Act 1968 (as substituted by section 13 of the Medical Practitioners Amendment Act 1970), His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the advice of the Minister of Health after consultation by that Minister with the Medical Council of New Zealand, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Medical Practitioners (Fees) Regulations 1987.

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Fees—(1) There shall be paid to the Medical Council of New Zealand for each matter specified in the Schedule to these regulations the fee specified for it in the Schedule.

(2) Notwithstanding the provisions of subclause (1) of this regulation, and the revocation, by regulation 3 of these regulations, of the Medical

Practitioners (Fees) Regulations 1985* and the Medical Practitioners (Fees) Regulations 1985, Amendment No. 1†, the fee payable for any annual practising certificate issued in respect of the year ending with the 31st day of March 1987 shall be \$40.

3. Revocations—The Medical Practitioners (Fees) Regulations 1985* and the Medical Practitioners (Fees) Regulations 1985, Amendment No. 1†, are hereby consequentially revoked.
