## THE MINING REGULATIONS 1926, AMENDMENT NO. 14

# C. W. M. NORRIE, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 21st day of December 1955

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Mining Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. (1) These regulations may be cited as the Mining Regulations 1926, Amendment No. 14, and shall be read together with and deemed part of the regulations under the Mining Act 1926, made on the 9th day of November 1926\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 6th day of January 1956.
- 2. (1) The principal regulations are hereby amended by revoking regulation 170, and substituting the following regulation:
- "170. On or before the fifth day of each of the months of April, July, October, and January in each year, every licensed gold dealer and the manager at every such branch of an incorporated bank holding a gold dealer's licence shall forward to the Under-Secretary of Mines a return in Form 105 in the Fifth Schedule hereto, containing the particulars therein prescribed with regard to every transaction relating to gold undertaken by him or by his bank during the last preceding three months."

(2) The Fifth Schedule to the principal regulations is hereby amended as follows:

(a) By omitting from the heading to Form 105 the words "the month 19 ", and substituting the words "the three months ending on the day of

(b) By omitting from Form 105 the words "5th day of each month". and substituting the words "5th day of each of the months of April, July, October, and January":

(c) By omitting from the form of certificate set out in Form 105 the words "the month ending", and substituting the words "the three months ending".

#### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

The effect of these regulations is that returns required to be made by licensed gold dealers and by incorporated banks will be made at intervals of three months and not at monthly intervals, as was the case formerly.
