## THE MINING REGULATIONS 1926, AMENDMENT NO. 15

BERNARD FERGUSSON, Governor-General

### ORDER IN COUNCIL

At the Government Buildings at Wellington this 10th day of June 1963

Present:

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL

PURSUANT to the Mining Act 1926, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. (1) These regulations may be cited as the Mining Regulations 1926, Amendment No. 15, and shall be read together with and deemed part of the regulations under the Mining Act 1926, made on the 9th day of November 1926\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. (1) Regulation 37 of the principal regulations is hereby amended by revoking subclause (21), and substituting the following subclauses:

“(21) The survey fees shall, in the case of each survey, be payable according to the scale for the time being fixed in respect of surveys of that kind by the scale of charges of the New Zealand Institute of Surveyors made under the Surveyors Act 1938.

“(21A) Where it is necessary to reduce the size of claims or other areas after survey, the amount of the cost on that scale must be deposited before the survey is made or the licence is issued.”

(2) Regulation 37 of the principal regulations is hereby further amended by omitting from subclause (26) the word "half", and substituting the word "three-quarters".

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations provide that, instead of the fees for surveys as set out in the principal regulations, the fees are to be according to the scale of the New Zealand Institute of Surveyors.

The regulations also increase from a half to three-quarters the maximum progress payments that may be made to surveyors.
